The New Mexico Environment Department (NMED) has reviewed the document: *Proposed Revision Number 14 to the Mixed Waste Site Treatment Plan (STP), Compliance Plan Volume (CPV), for Sandia National Laboratories/New Mexico, June 2013*, with cover letter dated June 27, 2013. NMED conducted a public comment period for Revision Number 14 from August 27, 2014 through September 26, 2014. No public comment was received.

Revision 14 is comprised of two Parts: X.C.2.a and X.C.2.b. Revisions under Part X.C.2.a set forth a new compliance date of December 31, 2016, for all treatment technologies and associated treatability groups (TG). Additionally, the revision updates the STP to include treatment technologies that are now available, and removes activities that have been completed and are no longer applicable. Revisions under Part X.C.2.b establish a compliance date of December 31, 2016 for the treatment and disposal of Mixed TRU (MTRU) waste.
