Mr. Bill Grantham, Counsel for NMED, spoke in agreement with the Respondent in its opposition to the Motion to Intervene.**

ACTION: Mr. Terry will draft the Order for Well 2 Web, Inc., OSHA 08-022, Order of Default.


Item #11 Next Meeting
