<u>Air Quality Operating Permit</u> for Florida Compressor Station of El Paso Natural Gas Company, LLC

El Paso Natural Gas Company, LLC at 1001 Louisiana Suite 1000; Houston, TX 77002 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Florida Compressor Station. The owner of this plant is El Paso Natural Gas Company, LLC. The exact location of the facility is at latitude 32 deg, 13 min, 3 sec and longitude -107 deg, 25 min, 18 sec, Datum: WGS84. To aid in locating this facility, the approximate location is as follows: from I-10 in Deming, take Exit 102. Turn left onto NM549E and almost immediately turn right onto CR8049; travel one mile and turn right onto Franklin Rd., which ends at the facility entrance. This facility is located approximately 16 miles east of Deming in Luna County, New Mexico. This application file has been assigned an Operating Permit Number P137-R4 and TEMPO Agency Interest ID No. 868.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress natural gas for the purpose of transporting it to another facility or a major transportation pipeline.

This operating permit application is for a Title V permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporation of a modification made to the NSR construction permit, which consisted of updating existing carbon monoxide (CO) emission limits from startup, shutdown, and maintenance (SSM) activities associated with a simple-cycle turbine.

The emissions, as established in NSR Permit PSD2811-M4, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P137-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 935.5 tpy (no change); Carbon Monoxide (CO) at 201.2 tpy (-0.5); Volatile Organic Compounds (VOC) at 28.3 tpy (no change); Sulfur Dioxide (SO₂) at 4.4 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 11.4 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 11.4 tpy (no change); and greenhouse gas (CO₂e) > 75,000 tpy (no change).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A and GG; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before July 29, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P137-R4 by contacting Rebecca Procter at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
