For

Air Quality Operating Permit

for Sand Point Landfill of Eddy (County Of) and Carlsbad (City of)

The City of Carlsbad and Eddy County at 101 W Greene Street; Carlsbad, NM 88220 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for the jointly owned Sand Point Landfill. The exact location of the facility is at latitude 32 deg, 29 min, 55.92 sec and longitude -104 deg, 3 min, 56.22 sec, Datum: WGS84. This facility is located approximately 12 miles East of Carlsbad in Eddy County, New Mexico. The exact address of the facility is 164 Landfill Road, Carlsbad, New Mexico, 88220. This application file has been assigned an Operating Permit Number P190L-R3 and TEMPO Agency Interest ID No. 511.

Previously, the plant received an air quality construction permit, if one was required, and is in operation or able to operate. The main purpose of the facility is to dispose of non-hazardous residential, commercial, and industrial waste. Sand Point Landfill does not accept petroleum-contaminated soils. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves no changes.

The emissions, as established in TV Permit P190-R2M1, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit. Emissions are expressed in tons per year (tpy). Volatile Organic Compounds (VOC) at 3.1 tpy (+0.9); Particulate Matter 10 microns or less (PM₁₀) at 5.7 tpy (-0.3); and Particulate Matter 2.5 microns or less (PM_{2.5}) at 2.3 tpy (-0.3); Projected emissions of Non-methane organic compounds (NMOCs) for 2025 are 7.6 Mg/y (LanGEM analysis). Total HAPs emissions are 0.5 tpy (-0.8). The facility is a minor source of greenhouse gas emissions at < 75,000 tpy CO₂e.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 3, 7, 64, 70, 71, 73, and 77; 40 CFR 50; 40 CFR 60 Subparts A, WWW, and XXX; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before May 28, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P190L-R3 by contacting Julia Kuhn at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
