<u>Air Quality Operating Permit</u> for Lovington Refinery of HollyFrontier Navajo Refining LLC

HollyFrontier Navajo Refining LLC at PO Box 159; Artesia, NM 88211-0159 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Lovington Refinery. The owner of this plant is HollyFrontier Navajo Refining LLC. The exact location of the facility is at latitude 32 deg, 52 min, 45.8292 sec and longitude -103 deg, 18 min, 1.7151 sec, Datum: NAD83. To aid in locating this facility, the approximate location is 5 miles southeast of Lovington, in Lea County, New Mexico. This application file has been assigned an Operating Permit Number P020-R3 and TEMPO Agency Interest ID No. 622.

Previously, the facility received an air quality construction permit and is in operation. This facility is a crude oil refinery. The major processes associated with the facility are as follows: The atmospheric tower, the vacuum distillation unit, the stabilizer, the depropanizer and the MEROX treater. Support operations include the boiler, the cooling tower, the LPG, asphalt, gas oil, jet fuel/kerosene and crude oil loading racks. The facility also has a wastewater treatment system, flare and Volatile Organic Compounds (VOC) Liquid storage tanks.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporating changes authorized by NSR Permits 0273M10 and renewing the operating permit.

The emissions, as established in NSR Permit 0273-M10, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit action – P020-R2; emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 101.8 tons per year (tpy) (+10); Carbon Monoxide (CO) at 189.6 tpy (+10); Volatile Organic Compounds (VOC) at 220.3 tpy (+11.3); Sulfur Dioxide (SO2) at 37.8 tpy (NC); Particulate Matter 10 microns or less (PM10) at 17.3 tpy (NC), and Particulate Matter 2.5 microns or less (PM2.5) at 17.3 tpy (NC. The facility is a major, >75,000 tpy CO₂e, source of green house gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this plant will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 33, 36, 37, 38, 70, 72, 73, 74, 75, 77, 78, and 82; 40 CFR 50; 40 CFR 60 Subparts J, Ja, k. VV, GGG, GGGa, IIII, and QQQ; 40 CFR 61 Subpart FF; 40 CFR 63 Subpart CC and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before February 18, 2021.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P020R3 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
