## <u>Air Quality Operating Permit</u> for Harvest 32-7 CDP Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Harvest - 32-7 CDP Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility **is** at latitude 36 deg, 55 min, 53 sec and longitude -107 deg, 33 min, 37 sec, Datum: NAD83. This facility is located approximately 9 miles NNE of Navajo Dam in San Juan County, New Mexico. This application file has been assigned an Operating Permit Number P195-R3M2 and TEMPO Agency Interest ID No. 1221.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress and dehydrate pipeline quality natural gas from independent producers. This operating permit application is for a permit modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporation of the following changes: removal of one 150 bbl produced water storage tank, addition of two 300 bbl produced water tank, addition of one 500 bbl produced water tank, and change in ownership name.

The emissions, as established in NSR Permit 1032-M9 and brought forward into this permit, are as follows. Parentheses note changes in emissions from previous operating permit: P195-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 201.5 tpy (-0.2); Carbon Monoxide (CO) at 246.0 tpy (-0.5); Volatile Organic Compounds (VOC) at 232.9 tpy (+4.0); Sulfur Dioxide (SO<sub>2</sub>) at 0.46 tpy (no change); Particulate Matter (PM) at 7.7 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 7.7 tpy (no change); and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 7.7 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, and 82; 40 CFR 50; 40 CFR 63 Subpart HH; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before August 16, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P195-R3M2 by contacting Olivia Yu at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
