<u>Air Quality Operating Permit</u> for Cedar Hill Compressor Station of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Cedar Hill Compressor Station. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is at latitude 36 deg, 56 min, 58 sec and longitude -107 deg, 54 min, 27 sec, Datum: WGS 84. This facility is located approximately 2.2 miles northwest of Cedar Hill in San Juan County, New Mexico. This application file has been assigned an Operating Permit Number P173R4 and TEMPO Agency Interest ID No. 1331.

Previously, the facility received an air quality construction permit and is in operation. There are no changes to the existing air emission limits in this permitting action. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves Title V permit renewal. The main purpose of the facility is to compress gas and send it to a pipeline.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, and 73; 40 CFR 50; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before November 21, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P173R4 by contacting Todd Sherrill at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
