Air Quality Operating Permit  
for Caprock Compressor Station of El Paso Natural Gas Company, L.L.C.

El Paso Natural Gas Company, L.L.C. at 5151 E. Broadway Blvd., Suite 1680, Tucson, AZ 85711 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Caprock Compressor Station. The owner of this plant is El Paso Natural Gas Company, L.L.C. The exact location of the facility is at latitude: 33 deg, 19 min, 54.7 sec; longitude: -103 deg, 34 min, 30.5 sec; Datum: WGS84. To aid in locating this facility, the approximate location is 16.2 miles W of Tatum in Lea County, NM. This application file has been assigned an Operating Permit Number P132-R4 and TEMPO Agency Interest ID No. 572.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress and transport pipeline quality natural gas. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves no changes.

The emissions, as established in NSR Permit 3261-M1 and brought forward into this permit are as follows. There are no changes to the existing air emission limits in this permitting action. Parentheses note changes in emissions from previous operating permit – P132-R4. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 373.2 tpy (no change); Carbon Monoxide (CO) at 67.3 tpy (no change); Volatile Organic Compounds (VOC) at 18.3 tpy (no change); Sulfur Dioxide (SO<sub>2</sub>) at 3.4 tpy (no change); Particulate Matter (PM) at 2.9 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 2.9 tpy (no change); Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 2.9 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) at < 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, and 82; 40 CFR 50; 40 CFR 63 Subparts A and ZZZZ; 40 CFR 82; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before December 20, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P132-R4 by contacting Olivia Yu at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
