

**Legal Notice for
Air Quality Operating Permit
for South Eddy Cryogenic Plant of Enterprise Field Services, LLC**

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 772104324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its South Eddy Cryo Plant. The owner of this plant is Enterprise Field Services LLC. The exact location of the facility is/will be at latitude 32 deg, 9 min, 40.64 sec and longitude - 103 deg, 49 min, 42.09 sec Datum: WGS84. To aid in locating this facility, the approximate location is ~18 mi SE of Loving in Eddy County, NM. This application file has been assigned an Operating Permit Number P282 and TEMPO Agency Interest ID No. 34514.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to treat and process natural gas cryogenically for Enterprise's gathering systems located throughout southeastern New Mexico.

This operating permit application is for a new permit. Per 20.2.70.401.C.(4) NMAC, this permitting action involves issuing a new operating permit for a facility that currently has a New Source Review permit.

The estimated maximum air pollutant emissions to the atmosphere from this facility after the requested operating permit is issued, are as follows. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 70.97 tpy (-0.23); Carbon Monoxide (CO) at 147.71 tpy (-12.39); Volatile Organic Compounds (VOC) at 240.05 tpy (-17.35); Sulfur Dioxide (SO₂) at 8.51 tpy (-33.39); Hydrogen Sulfide at 0.087 tpy (-1.01); Particulate Matter 10 microns or less (PM₁₀) at 5.13 tpy (-2.07), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 4.78 tpy (-2.12); and greenhouse gas (CO₂e) > 75,000 tpy.

The facility is a major (>100,000 tpy CO₂e) source of greenhouse gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 3, 7, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, Dc, OOOO, and JJJJ; 40 CFR 63 Subparts A, and HH; 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before September 5, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P282 by contacting Rebecca Procter at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and

the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public. The permit application is currently available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/air-quality/public-notices-of-permitting-actions/.
