## Air Quality Operating Permit for Bloomfield Products Terminal of Western Refining Terminals, LLC

Western Refining Terminals, LLC at 19900 Ridgewood Parkway, San Antonio, Texas 78259 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Bloomfield Products Terminal. The owner of this plant is Western Refining Terminals, LLC. The exact location of the facility is at latitude 36 deg, 41 min, 50 sec and longitude -107 deg, 58 min, 20 sec Datum: NAD27. To aid in locating this facility, the approximate location is 0.25 mile South of Bloomfield in San Juan County, NM. This application file has been assigned an Operating Permit Number P024-R3 and TEMPO Agency Interest ID No. 1156.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to receive materials via the loading rack, pipelines, or trucks. The facility stores the materials in storage tanks and loads the materials out via the loading rack, pipelines, or trucks. This operating permit application is for a permit renewal.

There are no existing air emission changes in this permitting action. The estimated maximum air pollutant emissions to the atmosphere from this facility, as expressed in tons per year (tpy), are: Nitrogen Oxides (NOx) at 11.1 tpy; Carbon Monoxide (CO) at 8.3 tpy; Volatile Organic Compounds (VOC) at 240.8 tpy; Sulfur Dioxide (SO<sub>2</sub>) at 1.4 tpy; Particulate Matter 10 microns or less (PM<sub>10</sub>) at 1.1 tpy; Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 1.1 tpy; and greenhouse gas (CO<sub>2</sub>e) < 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, Dc, K, Ka, and Kb; 40 CFR 63 Subparts A, EEEE, ZZZZ, and BBBBBB; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before October 25, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P024-R3 by contacting Marvin Mascareñas at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
