## <u>Air Quality Operating Permit</u> for Lincoln Compressor Station of El Paso Natural Gas Company, LLC

El Paso Natural Gas Company, LLC at 5151 East Broadway, Suite 1680, Tucson, AZ 85711 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for renewal of an air quality operating permit for its Lincoln Compressor Station. The owner of this plant is El Paso Natural Gas Company, LLC. The exact location of the facility is at latitude 34 deg, 6 min, 58.5 sec and longitude -105 deg, 40 min, 3.11 sec Datum: WGS84. The approximate location of this facility is 10.1 miles southwest of Corona in Lincoln County, NM. This application file has been assigned an Operating Permit Number P022-R4 and TEMPO Agency Interest ID No. 843.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to transport natural gas through pipelines using a natural gas fueled turbine. The facility also includes one auxiliary generator.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the operating permit and revision of emission limits in the operating permit to match emission limits already permitted in NSR Permit 0691-M4.

The emissions, as established in NSR Permit 0691-M4 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P022-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 310.0 tpy (no change); Carbon Monoxide (CO) at 55.6 tpy (no change); Volatile Organic Compounds (VOC) at 21.3 tpy (no change); Sulfur Dioxide (SO<sub>2</sub>) at 4.6 tpy (+4.4 tpy); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 2.4 tpy (no change), Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 2.4 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) 53,767 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, 78, and 82; 40 CFR 50; 40 CFR 61 Subparts A and M; 40 CFR 63 Subparts A and ZZZZ; 40 CFR 82 and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before November 27, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P022-R4 by contacting Kirby Olson at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
