Legal Notice For <u>Air Quality Operating Permit</u> for El Cedro Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its El Cedro Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is at latitude 36 deg, 41 min, 20.5 sec and longitude -107 deg, 24 min, 6.2 sec Datum: NAD83. To aid in locating this facility, the approximate location is 18 mi ESE of Navajo Dam in Rio Arriba County, NM. This application file has been assigned an Operating Permit Number P046-R3M1 and TEMPO Agency Interest ID No. 1002.

Previously, the facility received an air quality construction permit and is in operation. The facility is a natural gas compressor station and receives and distributes gas from two gathering system, the San Juan Conventional (SJC) gathering system and Manzanares gathering system. The compressors are powered by natural gas fueled engines and the facility generates its own electric power using two natural gas fueled generators.

This operating permit application is for a permit modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves increasing condensate throughput to the storage tanks, increasing produced water throughput to the storage tanks, increasing truck loading throughput, increasing pig receiver throughput and adding an exempt produced water tank.

The emissions, as established in NSR Permit PSD0340-M15 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P046-R3M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 319.0 tons per year (tpy) (+1.5); Carbon Monoxide (CO) at 446.0 tpy (+1.9); Volatile Organic Compounds (VOC) at 253.0 tpy (-57.8); Sulfur Dioxide (SO2) at 3.0 tpy (+0.1); Particulate Matter 10 microns or less (PM10) at 11.0 tpy (+0.7), and Particulate Matter 2.5 microns or less (PM2.5) at 11.0 tpy (+0.7), and green house gas (CO_2e) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 7, 61, 72, 73, 74, 75, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A and GG; 40 CFR 63 Subparts HH and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before April 17, 2021.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P046-R3M1 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
