For
Air Quality Operating Permit
for La Jara Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Drive; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its La Jara Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 36.817222, -107.492222 Datum: WGS84. To aid in locating this facility, the approximate location is 12 mi E of Navajo Dam in Rio Arriba County, NM. This application file has been assigned an Operating Permit Number P023-R4 and TEMPO Agency Interest ID No. 1010.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to dehydrate and compress natural gas through underground natural gas pipelines using natural gas fired combustion turbines. The facility is permitted to operate five turbines, one emergency generator, three condensate tanks along with truck loadout.

This operating permit application is for permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporation of NSR permit 339-M9 that was issued on November 16, 2020. The primary purpose of the permit 339-M9 modification was to improve the performance of the station's compression capabilities. Harvest's plan was to replace one or both of turbine Unit 1 and Unit 2 with upgrade Unit 8 and Unit 9, respectively. The replacement of the turbine(s) would take place during a normally scheduled maintenance operation. If implemented, the turbine upgrade(s) will result in a reduction in the Potential to Emit (PTE) for nitrogen oxides (NO_x), carbon monoxide (CO) and volatile organic compounds (VOC) emissions from the turbine(s) and a net air quality benefit.

The emissions, as established in NSR Permit 339-M9 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P023-R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 272.6 tpy (no change); Carbon Monoxide (CO) at 186.6 tpy (no change); Volatile Organic Compounds (VOC) at 168.7 tpy (-139.5); Sulfur Dioxide (SO₂) at 2.6 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 5.2 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 5.2 tpy (no change); and greenhouse gas (CO₂e) 125,722 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 74, 75, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, GG, KKKK and OOOOa; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before September 8, 2022.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P023-R4 by contacting Urshula Bajracharya at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public. The permit application is currently available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/public-notices.
