11 **20.2.87.2 SCOPE:** All persons who own or operate an applicable source of greenhouse gas emissions in the  
12 geographic areas within the jurisdiction of the Environmental Improvement Board.

15 **20.2.87.3 STATUTORY AUTHORITY:** Environmental Improvement Act, NMSA 1978, Section 74-1-8(A)(4),  
16 and Air Quality Control Act, NMSA 1978, Sections 74-2-1 et seq., including specifically Sections 74-2-5(B)(1) & 74-2-  
17 (5)(C)(5)(d) & (e).

20 **20.2.87.4 DURATION:** Permanent.

23 **20.2.87.5 EFFECTIVE DATE:** January 1, 2008 except where a later date is cited at the end of a section or  
24 paragraph.

27 **20.2.87.6 OBJECTIVE:** The objective of this Part is to establish requirements for the annual reporting of  
28 greenhouse gas emissions to the Department using tools and procedures similar to those used by greenhouse gas emissions  
29 registries.

32 **20.2.87.7 DEFINITIONS:** In addition to the terms defined in 20.2.2 NMAC, the following definitions shall apply to  
33 terms used in this Part.

34 **A. "California climate action registry"** means the voluntary registry for greenhouse gas emissions  
35 established pursuant to California Health & Safety Code D. 26, Pt. 4, Ch. 6 (West 2007).

36 **B. "carbon dioxide equivalent"** means quantity of a given greenhouse gas multiplied by a conversion factor  
37 provided in the emissions reporting tool and procedures under subsection B of 20.2.87.202. NMAC.

38 **C. "direct emissions"** means emissions from sources at the facility.

39 **D. "emission report or inventory"** means a listing, by source, of the amount of air pollutants discharged into  
40 the atmosphere.

41 **E. "equity share"** means the extent of economic interest held in a facility, which is typically the same as  
42 ownership percentage.

43 **F. "facility"** means any building, structure, facility, or installation that emits or may emit any greenhouse gas.

44 **G. "indirect emissions"** means emissions that are a consequence of the operation under the control of the  
45 person filing a report, but which occur at a source owned or controlled by another entity.

46 **H. "metric ton"** means 2204.62 pounds.

47 **I. "operational control"** means having the authority to introduce and implement operating policies at the  
48 facility or operation.

49 **J. "reporting year"** means the calendar year in which emissions required to be reported under this Part  
50 occurred.

51 **K. "the climate registry"** means the nonprofit corporation incorporated for the purpose of creating and  
52 operating a multi-state greenhouse gas emissions registry.

1 **20.2.87.8 SEVERABILITY.** If any provision of this Part, or the application of such provision to any person or  
2 circumstance, is held invalid, the remainder of this Part, or the application of such provision to persons or circumstances  
3 other than those as to which it is held invalid, shall not be affected thereby.

19 **20.2.87.200 APPLICABILITY**

20 **A.** The following shall report greenhouse gases under this Part, with 2008 as the first greenhouse gas reporting  
21 year.

22 (1) Any owner or operator of a facility at which the sum of the nameplate capacity of all electrical generating  
23 units is equal to or greater than twenty-five megawatts of electricity.

24 (2) Any owner or operator of a petroleum refining facility with a NAICS code 32411.

25 (3) Any owner or operator of a cement manufacturing facility with a NAICS code 32731.

26 **B.** Owners or operators that are not required to report greenhouse gas emissions under this Part may do so  
27 voluntarily.

28 **C.** Owners or operators that are required to report greenhouse gas emissions under this Part may voluntarily  
29 include additional emissions that are not required under this Part.

30 **D.** Owners or operators required to report greenhouse gas emissions under this Part may register and verify  
31 their greenhouse gas emissions with the climate registry or the California climate action registry. Owners or operators that  
32 have so registered and verified their greenhouse gas emissions for the greenhouse gas emissions reporting year shall be  
33 deemed to be in compliance with this Part for that reporting year if:

34 (1) the greenhouse gas emissions reported for the reporting year include, at a minimum, the emissions that  
35 would be reported for that owner or operator for that year under this Part; and

36 (2) the department has access to, at a minimum, the information required by subsection B.

39 **20.2.87.201 GREENHOUSE GAS EMISSIONS REPORTING REQUIREMENTS**

40 **A.** Requirements for the first reporting year. The owner or operator shall report at a minimum all direct  
41 emissions of carbon dioxide from the facility, except as provided in subsection D of this section.

42 **B.** Requirements for the second reporting year. The owner or operator shall report at a minimum:

43 (1) all direct emissions of carbon dioxide from the facility, except direct emissions from motor and nonroad  
44 vehicles; and

45 (2) indirect greenhouse gas emissions from all electricity, steam, and heat purchased and consumed at the  
46 facility.

47 **C.** Requirements for the third and subsequent reporting years. The owner or operator shall report at a  
48 minimum:

49 (1) all direct emissions of greenhouse gases from the facility, except direct emissions from motor and nonroad  
50 vehicles; and

51 (2) indirect greenhouse gas emissions from all electricity, steam, and heat purchased and consumed at the  
52 facility.

55 **20.2.87.202 GREENHOUSE GAS EMISSIONS REPORTING PROCEDURES**

1           **A.** Owners or operators that meet the applicability requirements in section 20.2.87.200 NMAC shall submit  
2 annual greenhouse gas emissions reports under this Part. Greenhouse gas emissions reports shall apply to a calendar year.

3           **B.** Except as provided under subsection D of 20.2.87.200 NMAC, reporting shall be conducted using the  
4 greenhouse gas emissions reporting tool and procedures provided by the department. Such tool and procedures shall:

5           (1) be made available by the Department to the public for review and comment at least sixty days prior to the  
6 beginning of a greenhouse gas emission reporting year; Department notifications of the availability of the tool and procedures  
7 for review may be made electronically or in writing;

8           (2) be consistent, to the extent feasible, with emissions quantification methods and best practices accepted by  
9 the climate registry or the California climate action registry;

10           (3) include recommended methods for estimation of greenhouse gas emissions from equipment and processes  
11 for which emissions calculations are required, including conversion factors for each greenhouse gas into carbon dioxide  
12 equivalent, and the supporting data that is required for use of such methods;

13           (4) include alternate methods for estimation of greenhouse gases, where such alternate methods are available;

14           (5) provide, as the department deems appropriate, for simplified and limited documentation of emissions that  
15 collectively account for five percent or less of total facility emissions, expressed as carbon dioxide equivalent;

16           (6) require that the owner or operator include in each annual report a certification signed by the owner or  
17 operator attesting that the statements and information contained in the emissions report are true and accurate to the best  
18 knowledge and belief of the certifying official, and including the full name, title, signature, date of signature, and telephone  
19 number of the certifying official;

20           (7) include provisions to report:

21           (a) the name and address of the reporting owner or operator;

22           (b) the name and telephone number of the person to contact regarding the emissions report;

23           (c) for emissions from facilities within the jurisdiction of the Environmental Improvement Board, the  
24 county in which the facilities are located;

25           (d) for emissions from facilities located on Tribal Lands, if reported, the Tribe or Pueblo;

26           (e) for emissions from facilities located in another state or territory of the United States, if reported, the  
27 state or territory;

28           (f) for emissions from facilities located in another country, if reported, the country;

29           (g) fuel use, including amounts and specifications of each fuel type, directly related to reported  
30 emissions;

31           (h) the means to document methods utilized to make emissions calculations, if different from the  
32 methods incorporated into the tool;

33           (i) calculations for emissions of each reported greenhouse gas and the means to sum all reported  
34 greenhouse gases, in units of metric tons of carbon dioxide equivalent, including emissions occurring during regular  
35 operation, maintenance, start-ups, shutdowns, upsets, and malfunctions; and

36           (j) a listing, including percentages, of the owners of equity shares of the emissions reported.

37           **C.** Reporting owners or operators shall submit reports required under this Part by July 1 of the year following  
38 the greenhouse gas emissions reporting year.
