

# LEGAL NOTICE

For

Air Quality Operating Permit

for Trunk N Compressor Station of Williams Four Corners LLC

Williams Four Corners LLC at 1755 Arroyo Drive; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Trunk N Compressor Station. The owner of this plant Williams Four Corners LLC. The exact location of the facility is at latitude 36 deg, 5 min, 00 sec and longitude -107 deg, 35 min, 15 sec, Datum: NAD83. To aid in locating this facility, the approximate location is approximately 25 miles east northeast of Aztec in San Juan county. This application file has been assigned an Operating Permit Number P198-R3 and TEMPO Agency Interest ID No. 1303. The facility was not required to obtain an air quality construction permit and is in operation.

The main purpose of the facility is to compress and dehydrate pipeline quality natural gas. The tanks are used to store lubrication oil, used oil, glycol, antifreeze, and produced/waste water. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewing the Title V operating permit.

Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 96.2 tpy (no change); Carbon Monoxide (CO) at 290.9 tpy (no change); Volatile Organic Compounds (VOC) at 119.4 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 3.7 tpy (no change), Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 3.7 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) >75,000 tpy. Greenhouse gas emissions were not previously reported.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance. The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 74, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ; 40 CFR 63 Subparts A, HH, and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before December, 2016.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P198R3 by contacting Roslyn Higgin at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816. Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
