For

Air Quality Operating Permit

for Dogie Canyon Compressor Station of Williams Four Corners LLC

Williams Four Corners LLC at 188 County Road 4900; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Dogie Canyon Compressor Station. The owner of this plant is Williams Four Corners LLC. The exact location of the facility is at latitude 36 deg, 26 min, 2.4 sec, and longitude -107 deg, 28 min, 47.6 sec, Datum: NAD83. To aid in locating this facility, the approximate location is 15 miles north of Counselor, NM in Rio Arriba County. This application file has been assigned an Operating Permit Number P019-R3 and TEMPO Agency Interest ID No. 990.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress natural gas for pipeline transportation to another facility or a major transportation pipeline.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action will update and incorporate any/all applicable requirements, including new source review (NSR) permit actions not already incorporated into the TV permit. In particular, this renewal will be incorporating NSR revisions made through Permits 762-M5 (issued May 14, 2015) and 762-M6 (issued September 4, 2015).

The emissions, as established in NSR Permit 762-M6, and brought forward into this permit are as follows. Parentheses note changes in emissions from the previous operating permit (P019-R2). Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 247.6 tpy (+27.4); Carbon Monoxide (CO) at 233.4 tpy (+25.1); Volatile Organic Compounds (VOC) at 468.0 tpy (+33.3); Sulfur Dioxide (SO₂) at 2.0 tpy (+0.6); Particulate Matter 10 microns or less (PM₁₀) at 3.9 tpy (+1.2), Particulate Matter 2.5 microns or less (PM_{2.5}) at 3.9 tpy (+1.2); and greenhouse gas (CO₂e) > 100,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance. The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 74, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, GG, and IIII; 40 CFR 63 Subparts A, HH, and ZZZZ; 40 CFR 64 CAM; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before November 24, 2016.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P019-R3 by contacting Jim Nellessen at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816. Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
