

**PUBLIC NOTICE**  
For  
Air Quality Operating Permit  
for Quail Booster Station of DCP Midstream, L.P.

DCP Midstream, L.P. at 10 Desta Drive, Suite 400 West, Midland, TX 79705 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Quail Booster Station. The owner of this plant is DCP Midstream, L.P.. The exact location of the facility is at latitude 32 deg, 23 min, 52.7219 sec and longitude -103 deg, 7 min, 24.6159 sec. To aid in locating this facility, the approximate location is 3.5 miles SE of Eunice in Lea County, New Mexico. This application file has been assigned an Operating Permit Number P096-R3 and TEMPO Agency Interest ID No. 679.

Previously, the facility received an air quality construction permit and is in operation. This operating permit application is for a permit renewal.

The main purpose of the facility is to compress natural gas for transport through a pipeline.

The emissions, as established in NSR Permit 122-M3, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit # P96-R2. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 912.0 tpy (-0.3); Carbon Monoxide (CO) at 356.0 tpy (no change); Volatile Organic Compounds (VOC) at 41.6 tpy (+0.6); Total Suspended Particulates (TSP) at 2.9 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 2.9 tpy (no change); and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 2.9 tpy (no change). The facility is a major, >100,000 tpy CO<sub>2e</sub>, source of green house gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, and 82; 40 CFR 50; 40 CFR 63, Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before January 24, 2015.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P096-R3 by contacting Melinda Owens at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
