Air Quality Operating Permit
for Frances Mesa Compressor Station of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Frances Mesa Compressor Station. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is at latitude 36 deg, 46 min, 49.6611 sec and longitude -107 deg, 33 min, 45.8042 sec. To aid in locating this facility, the approximate location is 26 miles east of Blanco in Rio Arriba County, New Mexico. This application file has been assigned an Operating Permit Number P170R2M2 and TEMPO Agency Interest ID No. 1038.

Previously, the plant received an air quality construction permit and is in operation. The main purpose of the plant is to gather pipeline natural gas, dehydrate and compress it for transportation.

This operating permit application is for a permit modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporating changes authorized by NSR Permit 1579M2.

The emissions, as established in NSR Permit 1579-M2, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit action – P170-R2; emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 155.9 tons per year (tpy)(No Change); Carbon Monoxide (CO) at 248.2 tpy (No Change); Volatile Organic Compounds (VOC) at 92.5 tpy (increase of 26.3); Sulfur Dioxide (SO₂) at 5.2 tpy (increase of 5.2); Total Suspended Particulate Matter (TSP) at 3.4 tpy (increase of 3.4), Particulate Matter 10 microns or less (PM10) at 3.4 tpy (increase of 3.4), and Particulate Matter 2.5 microns or less (PM2.5) at 3.4 tpy (increase of 3.4). The facility is a minor, < 100,000 tpy CO₂e, source of green house gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance status.

The NMED has made a preliminary determination that this plant will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 61, 72, 73, 75; 40 CFR 50; 40 CFR 63 Subparts HH and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before May 11, 2013.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P170R2M2. Contact the New Mexico Environment Department, Air Quality Bureau, Operating Permit Unit, 1301 Siler Rd, Bldg B, Santa Fe, New Mexico 87507-3113.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
