

# LEGAL NOTICE

For

Air Quality Operating Permit

for Lobo Compressor Station of Frontier Field Services LLC

Frontier Field Services LLC at 65 Mercado St, Suite 250; Durango, CO 81301 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for the Lobo Compressor Station. The owner of this plant is Frontier Field Services LLC. The exact location of the facility is at latitude 32 deg, 50 min, 14 sec and longitude -103 deg, 54 min, 53 sec, Datum: WGS84. To aid in locating this facility, the approximate location is 3.5 miles northeast of Loco Hills, New Mexico, in Eddy County. This application file has been assigned an Operating Permit Number P267 and TEMPO Agency Interest ID No. 31692.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress natural gas for pipeline transport.

This operating permit application is for a new Title V Permit. Per 20.2.70.401.C.(4) NMAC, the new operating permit incorporates monitoring conditions imposed in construction permit 4837-M2 with revision throughout to ensure adequate monitoring of emissions units at the facility and reflect changes to regulatory applicability.

The emissions, as established in NSR Permit 4837-M2, and brought forward into this permit are as follows. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 107.0 tpy; Carbon Monoxide (CO) at 62.3 tpy; Volatile Organic Compounds (VOC) at 130.5 tpy; Sulfur Dioxide (SO<sub>2</sub>) at 43.1 tpy; Total Particulate Matter, Particulate Matter 10 microns or less (PM<sub>10</sub>), and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 3.2 tpy; Hydrogen Sulfide (H<sub>2</sub>S) at 10.4 tpy; Total Hazardous Air Pollutants (HAPs) at 13.4 tpy; and greenhouse gas (CO<sub>2</sub>e) < 75,000 tpy. The facility is a minor, < 100,000 tpy CO<sub>2</sub>e, source of greenhouse gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ, and OOOO; 40 CFR 63 Subparts A, HH, and ZZZZ; 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before January 25, 2017.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P267 by contacting Linsey Hurst at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
