

**PUBLIC NOTICE**  
For  
Air Quality Operating Permit  
for North Hobbs Reinjection Compression and Injection Tank Battery

Occidental Permian Limited at P.O. Box 50250; Midland, TX 79705 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its North Hobbs Reinjection Compression and Injection Tank Battery. The owner of this plant is Occidental Permian Limited. The exact location of the facility is at latitude 32 deg, 43 min, 15.65 sec and longitude -103 deg, 12 min, 3.49 sec. To aid in locating this facility, the approximate location is 2.75 miles west of Hobbs in Lea County, New Mexico. This application file has been assigned an Operating Permit Number P253 and TEMPO Agency Interest ID No. 2415.

Previously, the plant received an air quality construction permit and is in operation.

The main purpose of the plant is to clean and compress field gas to re-injection pressure, process natural gas liquids, and separate oil from water.

This operating permit application is for a new permit. Per 20.2.70.401.C.(4) NMAC, this permitting action involves registering for a TV permit.

There are no changes in emissions in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance status.

The NMED has made a preliminary determination that this plant will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, and 74; 40 CFR 50; 40 CFR 60 Subparts KKK; 40 CFR 63 Subparts HH and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before April 24, 2013.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P253. Contact the New Mexico Environment Department, Air Quality Bureau, Operating Permit Unit, 1301 Siler Rd, Bldg B, Santa Fe, New Mexico 87507-3113.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
