

LEGAL NOTICE
and
Preliminary Determination for an Air Quality Permit for
Ready Roast Nut Company

Ready Roast Nut Company, 2805 Falcon Drive, Madera, CA has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to construct Ready Roast - Peanut Mill and Peanut Butter Plant. The application file has been assigned Permit No. 6609 and TEMPO Agency Interest ID No. 30084. The exact location of the facility is be at latitude 34 degrees, 12 minutes, 47.71 seconds and longitude -103 degrees, 18 minutes, 9.472 seconds. To aid in locating this facility, the approximate location is 42593 U.S. 70, Portales, NM 88130 in Roosevelt County. Take US-70 east out of Portales, NM Travel for 2.5 miles and the facility will be on the right.

The proposed modification will consist of 58.5 ton/hr offloader, 58.5 ton/hr conveyor and stick belt, 58.5 ton/hr sand screen shaker, 58.5ton/hr dirt cart, 33.75 ton/hr backup offloader, 33.75 ton/hr backup conveyor, 33.75 ton/hr backup sand screen shaker, 33.75 ton/hr backup dirt cart, 58.5 ton/hr stick cart, 58.5 ton/hr trailer loading, small dryers, semi dryers, 58.5 ton/hr main pit, 58.5 ton/hr seed pit, two (2) 12,100 CFM B&C Supply precleaner and inshell cleaning cyclone, 16,500 CFM LMC cleaning cyclone, 16,500 CFM LMC sheller cyclone, 386 dirt cart, 5,357 lbs.hr hull barn, 425 CFM B&C Supply Hayssen blower cyclone, 681 CFM B&C Supply transfer blower cyclone, 3.0 MMBtu/hr Blue Line salt dryers, two (2) 14,700 CFM stoner cyclones, 10,000 cleaner cyclone, 4,900 CFM LMC Ultra aspirator and blanching baghouse, 3.5 MMBtu/hr AeroGlide peanut butter plant roaster, and 2.0 MMBtu/hr Parker boiler.

Total air pollutant emissions to the atmosphere are estimated to be approximately Nitrogen Oxides (NO_x) at 11.2 tons per year (tpy); Carbon Monoxide (CO) at 8.8 tpy; Volatile Organic Compounds (VOC) at 0.6 tpy; Total Suspended Particulate Matter (TSP) at 11.3 tpy, Particulate Matter 10 microns or less (PM₁₀) at 8.9 tpy, and Particulate Matter 2.5 microns or less (PM_{2.5}) at 5.2 tpy, and green house gas (CO₂e) < 75,000 tpy These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. The preliminary review and applicant's analysis of ambient air quality impacts indicates that the facility's air emissions will meet the air quality standards for NO_x, CO, TSP, PM₁₀ and PM_{2.5} To determine compliance with national ambient air quality standards for ozone, NMED uses air monitors to monitor ozone concentrations. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice and determine compliance with ambient air quality requirements and standards.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 61, 72, and 73;and 40 CFR 50 and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before January 14, 2016. This source is a PSD minor source according to 20.2.74 NMAC.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions, hours of operation, production rate, and conditions that will require record keeping and reporting to the Department.

The permit application is available for review in electronic or hard copy at the Air Quality Bureau Office, 525 Camino de los Marquez Suite 1, Santa Fe, New Mexico. Manana, Unit 3, Clovis, NM 88101 for public review.

All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, facility name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The written comments should be mailed to Antonia Tallarico, New Mexico Environment Dept., Air Quality Bureau, Permit Section, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

The Department will notify all persons, who have provided written comments as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing before the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment before the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
