

#### Introduction

The Construction Programs Bureau (CPB) directly manages three funding sources, Capital Outlay Appropriations (CO), the Clean Water State Revolving Loan Fund Program (CWSRF), and the Rural Infrastructure Program (RIP). CPB engineering staff provide technical oversight for these funding programs. Over \$77 million was disbursed from the directly managed programs in the calendar year 2023.

CPB strives to ensure projects are sustainable, environmentally sound, completed on a timely basis, and free of waste, fraud, and abuse.





#### CWSRF as of 12/31/2023




#### RIP as of 12/31/2023

## Clean Water State Revolving Fund

The Clean Water State Revolving Fund provides low interest rate loans for a wide range of water quality projects including wastewater treatment projects, stormwater projects, and non-point source projects. The CWSRF receives annual capitalization grants from the US Environmental Protection Agency. A portion of each federal grant received may be awarded to borrowers as additional subsidization, to help defray the costs of borrowing. Currently, there are two interest rates for public entities: 0% or 0.01% depending on financial eligibility. Loan terms are up to thirty years. Applications for CWSRF funding are accepted year-round. Funding is provided on a reimbursement basis and loan repayment begins one year after project completion. In 2023, the CWSRF provided funding for 11 new projects, totaling \$37.6 million and awarded \$5.991 million in subsidy.

In 2023, the CWSRF signed five planning and design agreements with communities. Planning and design projects provide communities with a solid base to initiate infrastructure construction projects. The other six loans provided funding for construction of wastewater infrastructure. In 2023 CPB amended 27 loans for a variety of reasons including to lower interest rates, increase funding and extend the time for the project. Three million dollars in funding was added to three projects and nineteen projects required time extensions. Projects are experiencing long delays due to long lead times on equipment and materials for construction projects. Three loans going into repayment were refinanced to a 0.01% interest rate, saving those borrowers \$1.6 million.

As of 12/31/2023, the CWSRF had 36 active loans with an undisbursed balance of \$84.65 million and 73 loans In repayment with a balance due of \$151,428,210 million.

## **CWSRF Highlighted Project:**

## Village of Angel Fire Wastewater Treatment Plant Improvements CWSRF 107

The Village of Angel Fire in Colfax County received \$9.8 million dollars from the Clean Water State Revolving Loan Fund to construct upgrades to the existing wastewater treatment plant. The project includes new headworks, modifications to the existing influent pump station and septage dump station, new mixers and controls in the existing sequencing batch reactor basins, new influent equalization pond and lift station, new post equalization and post aeration basin, and replacement of the existing ultraviolet disinfection equipment. The project will be completed in early 2024 and will enable the Village to accommodate seasonal fluctuations in flows, improve effluent quality, and meet the limits of their discharge permit.

## **CWSRF Highlighted Project:**

## Los Alamos County White Rock Wastewater Treatment Plant CWSRF 110

Los Alamos County is in the process of constructing a new wastewater treatment plant to serve the White Rock community, with a population of just over 5,800. Construction is approximately 70% complete and the total cost of the construction is \$25.5 million dollars funded by the Clean Water State Revolving Loan Fund. The project will replace the aging 50-year-old trickling filter plant that currently serves White Rock and will ensure permit compliance for Los Alamos County. The project will also improve the effluent for expanded effluent reuse in the County. Construction completion is scheduled for September 2024.

## Rural Infrastructure Program

The Rural Infrastructure Program provides financial assistance for water, wastewater, and solid waste projects. RIP funds mutual domestic water consumers associations, water and sanitation districts, and municipalities that serve populations less than 20,000 and counties with populations less than 200,000. Funding is available for planning, design, and construction. In State Fiscal Year 2023, the RIP program received an infusion of cash from the legislature in the amount of \$10 million dollars. On April 12, 2023, the NMED CPB lowered the interest rate for RIP loans from 2.375% to 1%, making projects more affordable. Funding is provided on a reimbursement basis and repayment begins one year after project completion. This program is able to provide a quick turn-around time with loans finalized in 6-8 weeks if the borrower is also able to meet the requirements.

In 2023 there were 4 new loans executed for a total of \$975,000 in funding and one loan was amended to increase the funding by \$300,000. CPB worked with previously funded entities to amend their repayment agreements to lower the interest rate on loans in repayment to 1%. There were 17 refinance agreements executed in 2023 saving communities a total of \$1.6 million over the remaining life of the loans.

As of 12/31/2023, RIP had 10 active loans with an undisbursed balance of \$2.6 million and 65 loans in repayment with a balance due of \$17.5 million.



## **RIP Highlighted Project:**

## Chapelle MDWCA Water System Improvements RIP 00044

The Chapelle Mutual Domestic Water Consumer's Association in San Miguel County received \$150,000 from the Rural Infrastructure Loan Program to complete a water system improvements project. The project originally had only capital outlay and Water Trust Board funding and the amount of funding was insufficient to construct the complete project. The project includes construction of over 5,000 feet of new 3-inch water transmission line from the infiltration gallery that is their sole source of water. The new waterline replaces existing 3-inch cast iron waterline that is over 140 years old and was originally built and owned by the Atchison, Topeka, and Santa Fe railroad in the 1880s.




Chapelle MDWCA RIP 00044 Construction of New Waterline.

### **RIP Highlighted Project:**

## Lower Arroyo Hondo MDWCA Water System Improvements RIP 00039

The Lower Arroyo Hondo Mutual Domestic Water Consumers Association in Taos County received \$470,000 from the Rural Infrastructure Loan Program to complete a water system improvements project. The project originally had capital outlay and Water Trust Board funding and the amount of funding was insufficient to construct the complete project. The project includes construction of a new wellhouse and installation of approximately 3,000 feet of new waterline with valves, fire hydrants, and meters. The existing water supply well was located inside the old wellhouse which limited access to the well. This project included demolition of the old well house, rehabilitation of the existing well, and reconfiguring the wellhead outside the wellhouse for better access. The rebuilt well house has new piping, electrical/mechanical, and controls. The new 8-inch waterline replaces existing aging and undersized waterlines and will reduce water loss due to leaks and provide fire protection.

## **Capital Outlay Program**

Capital Outlay also known as Special Appropriations consists of state grants for infrastructure projects that are appropriated by the New Mexico Legislature and approved by the Governor. Funds are distributed through assigned state agencies.

Projects pertaining to water, wastewater, solid waste, or other environmental infrastructure are routinely assigned to NMED Construction Programs Bureau. CPB provides administrative support in accordance with DFA Capital Outlay Bureau guidelines and also provides technical support to the grantees through a staff of engineers.


The 2023 Legislature assigned CPB 133 new CO projects valued at \$62.8 million and 30 reauthorizations valued at \$14.7 million. The new capital outlay projects were funded using general fund and the reauthorizations were a combination of general fund and severance tax fund. Additionally, CPB was assigned three special appropriations totaling \$19.9 million.

As of 12/31/2023, CPB was performing administrative and technical oversight for 459 CO and SAP projects with an appropriated value of \$211 million and a remaining balance of \$167 million. From January 1, 2023, through December 31, 2023, CPB closed 81 projects valued at \$23.8 million and executed 155 grant agreements valued at \$83 million. In calendar year CPB processed 568 capital outlay disbursements totaling \$49.4 million dollars

## **CO Highlighted Project:**

## SAP 20-E2204-STB Southern Sandoval County Arroyo Flood Control Authority

The Lower Venada Arroyo Bank Stabilization project will stabilize the banks of the Lower Venada Arroyo in order to reduce the impacts of flooding. The project consists of the following:

- Construction of a riprap revetment along the banks of the arroyo to help protect the banks from erosion and scour.
- Installation of gabion baskets at key locations along the arroyo to provide additional protection.
- Installation of drainage structures to help to divert water away from the arroyo banks.
- Grading and reshaping of the arroyo banks to improve drainage and stability.

The project was awarded on January 30, 2023, and the Substantial Completion walk-through for the project was done on December 20th, 2023.

The total cost of the project was \$3.45 million, \$800,000 of which came from Capital Outlay and the remainder came from other sources including the Water Trust Board and the Office of the State Engineer.

The project is expected to provide SSCAFCA with a more resilient and sustainable flood control system. The project will help protect property and infrastructure from flooding, and improve the water quality in the arroyo.

### **CO Highlighted Project:**

## Williams Acres Sanitation District Water System Improvements SAP 19-D2485-GF, SAP 20-E2144-STB

The Williams Acres Water & Sanitation District is developing a water supply and distribution project to provide safe and reliable drinking water to its residents.

The need for this project is driven by three primary factors including health, sanitation, and security. McKinley County rural water systems struggle to provide reliable service due to limited water supplies and understaffing. The District currently lacks a water supply, forcing residents to rely on individual wells or hauled water, which poses health and sanitation risks. The project includes connecting to the Navajo Gallup Water Supply Project transmission line north of US Historic Highway 66, constructing water lines throughout the District's service area to provide individual connections to all homes, and upgrading or replacing existing infrastructure as needed.

Phase I, is nearly complete, and includes connecting the community to the Gallup water supply so fire protection will be available. The design of Phase II is in process and will connect the residents to the water supply along with metering. The project is expected to serve approximately 309 residents, including those in the Manuelito Navajo Children's Home and four commercial units.

# Sewer Overflow and Storm Reuse Municipal Grants Program

The Construction Programs Bureau participates in the Sewer Overflow and Stormwater Reuse Municipal Grant Program. This is an EPA Grant and program that was signed into law with America's Water Infrastructure Act of 2018 with the reauthorization of section 221 of the Federal Water Pollution Control Act (also known as the Clean Water Act or CWA). This grant is intended to address combined sewer overflows, sanitary sewer overflows, and stormwater management by making grants to states, who then make sub-awards to eligible entities for available projects.

The OSG program is closely aligned to the Clean Water State Revolving fund in terms of federal requirements and project eligibilities. Additionally, eligible OSG projects that are on the CWSRF Intended Use Plan are prioritized for OSG funding as are projects that are for financially distressed communities and projects that implement long-term sewer overflow control plans.

The City of Anthony (Anthony) was awarded grant funding from the initial OSG allocation as a project already on the CWSRF IUP and received additional grant funding from the second OSG allocation. Anthony is using the OSG grant, in addition to CWSRF funding, Colonias Infrastructure Funding, and capital outlay for the Adams Park and South Anthony Arroyo Flood Control project. The purpose of the project is stormwater diversion from the South Anthony Arroyo into the new Adams Park conveyance structure. The Adams Park structure, a baseball field and community green space, is designed to also serve as a conveyance and storage structure for stormwater during storm events. The University of New Mexico is also receiving funding for green stormwater infrastructure.


