ANNUAL REPORT CLEAN WATER STATE REVOLVING FUND PROGRAM

I. INTRODUCTION

The Federal Water Pollution Control Act, more commonly called the Clean Water Act (CWA), was enacted by Federal Legislation in 1972. The amended Clean Water Act of 1987 created the Clean Water State Revolving Fund (CWSRF). The State of New Mexico CWSRF Program (Program) was established in 1986 pursuant to the New Mexico Wastewater Facility Construction Loan Act, Section 74-6A-1 et seq, and amended by the New Mexico Statutes Annotated (NMSA) 1978.

The Program provides eligible borrowers in New Mexico with low-cost financial assistance for the construction of wastewater facilities or other eligible water quality projects. The loan program is maintained into perpetuity by adding repayment principal, interest, and investment interest to the fund. The Program has provided over \$569 million in funding for water quality protection to date (Attachment 1).

The State of New Mexico hereby submits the CWSRF Annual Report for state fiscal year (SFY) 2024. This report addresses how New Mexico worked toward the goals and objectives of the CWSRF Program identified in the approved SFY 2024 Intended Use Plan (IUP). This report describes the actual uses of CWSRF funds and the financial position of the Program.

II. PROGRAMMATIC DISCUSSION

The following sections report the financial activities and other elements impacting the CWSRF during SFY 2024.

A. Financial Highlights for State Fiscal Year 2024


- As of the close of State Fiscal Year (SFY) 2024, the NM CWSRF reports a total net position of \$407,419,491 an increase of \$23,364,855 for CWSRF Fund 12100 and CWSRF Admin Fund 32700 combined, or 6.1% annual growth. This growth rate is higher than in previous years due to increased federal funding, an extraordinarily low lending interest rate, and more aggressive marketing. (Attachment 2)
- The NM CWSRF was awarded four capitalization grants during SFY2024, the Bipartisan Infrastructure Law General Supplemental-2(BIL GS-2) for \$10,233,000, CWSRF Base Grant (Base) for \$3,683,000, and the first two CWSRF Emerging Contaminant Grants for \$459,000 and \$1,043,000(Attachment 1)
- The NM CWSRF collected \$13,858,194 in loan repayment principal, \$723,779in loan repayment interest, and \$286,579 in administrative loan fees. Total principal, repayment interest, and administrative fees received were \$14,868,552. (Attachment 2)
- The NM CWSRF earned \$7,314,039 in interest income on overnight funds deposited at the State Treasurer's Office for Fund 12100 and Fund 32700 combined. (Attachment 2)
- Fund 12100 disbursed \$23,502,855 for projects in SFY 2024. (Attachment 2)

• Fund 12100 incurred administrative expenses of \$527,046; Fund 32700 incurred administrative expenses of \$299,444. (Attachment 2), less than the budgeted amounts of \$750,900 and \$1,176,100 for the funds respectively. The actual numbers will be reflected when the audit has been accepted by the State.

B. Fund 12100 - The Loan Fund

The loan fund 12100 statement of net position shows that the fund grew by \$24,093,856 million during SFY 2024. The chart represented in Figure 1 represents the cumulative growth of the fund.

C. Factors Affecting the Fund

Multiple factors impact the performance of the Fund including competing programs, additional subsidization, investment earnings and more recently, the Bipartisan Infrastructure Law (BIL).

The Program's primary limiting factor is the New Mexico Capital Outlay Special Appropriations (CO SAP) program. CO SAP provides communities with 100% grant funding via legislative Capital Outlay appropriations. In 2023 the legislature awarded Capital Outlay appropriations that included 71 CWSRF eligible projects totaling \$40.2 million. These grants became active July 1, 2024. While the average amount of CO SAP awards is not large (\$566,125 for the referenced year), the prospect of "free" money is enough to dissuade local governments from utilizing loan funding, even at 0% or 0.01%. CO SAP has normalized grant funding. The NM CWSRF attempts to market specifically to CO SAP grantees attempting to co-fund larger projects. Our commitment is to honor all "free" funding awarded to communities, reducing the loan amount needed, to get a foot in the door.

NMED CPB administers the Rural Infrastructure Program (RIP) with the CWSRF. It is a small

state revolving loan program that provides loan and grant funding to rural communities. This program has an open application cycle and quick loan execution but has population restrictions and a maximum loan amount of two million dollars per year. The RIP program funded six wastewater projects totaling \$909,000 in SFY 2024. Both the CO SAP and RIP programs provide opportunities for co-funding.


As amended by the BIL, the CWA mandates that 10% but no more than 30% of the federal base capitalization grant is additional subsidy. Congress also mandated an additional 10% of the federal award appropriation as additional subsidization, not subject to CWA provisions. The BIL General Supplemental award mandate 49% additional subsidization subject to CWA provision. The BIL General Supplemental 2, awarded in FFY2023 (4C-02F14802-0), mandated \$5,014,170 be awarded as additional subsidization. The full amount has been awarded and agreements executed. For the FFY2023 CWSRF Base allotment, \$3,683,000 (CS-35000-23-0), the total additional subsidization that could be provided was \$1,473,200. As of 06/30/2024, additional subsidization assignments have been assigned but the agreements are not fully executed.

D. Interest Rate Structure

For the state fiscal year ending June 30, 2024, the NM CWSRF had three interest rates: 2.375% for private entities, 0.01% for public entities that do not qualify for 0% and for state agencies, and 0% for public entities with a PCI less than three-quarters of the statewide PCI and the average sewer user rate greater than 1.82% of the PCI.

E. Activities of the Program

As of June 30, 2024, the Program had forty-one projects in process. The Program drew down all the FFY2023 CWSRF Base Allotment and all the FFY2023 BIL GS-2 allotment. Consistent with long-standing EPA State Revolving Fund (SRF) practice, New Mexico "cuts the tie" between grant dollars and actual dollars and disburses funds from grants with universal eligibilities. This also allows New Mexico to follow first-in-first-out (FIFO) best practices. The NM CWSRF disbursed a total of \$23,502,855. in SFY 2024 from all sources. Figures 2 and 3.





F. Cash Flow Model

Cash flow models are management tools and reviewed and updated annually to reflect economic and programmatic changes.

The cash flow model chart presented (Figure 4) demonstrates that the CWSRF has the funds to support projected projects, and to increase funding where possible through enhanced outreach, expanded eligibilities and other funding opportunities. The projected cash flow shows the CWSRF can continue to effectively execute loans for environmentally important projects needed in New Mexico.

Annual sources of cash include loan repayments for principal, and repayment interest and overnight interest on investments. Annual uses of cash include loan and subsidy disbursements, and administrative expenses paid out of the Fund.



III. GOALS, OBJECTIVES, AND ACCOMPLISHMENTS

The Intended Use Plan for the SFY 2024 listed specific goals, objectives, and accomplishments; the following is a summary of our efforts.

A. Long-term Goals for State Fiscal Year 2024

1. Provide local authorities, state agencies, interstate agencies, and other qualified borrowers in New Mexico with low-cost financial assistance for the construction of wastewater facilities or other eligible water quality projects by maintaining a self-sustaining Clean Water State Revolving Fund (CWSRF).

This is an on-going goal for the Program. Low interest rates and full utilization of additional subsidization allow the Program to offer New Mexico entities affordable financing. New Mexico is currently offering an interest rate of 0.01% for all public entities that do not qualify for 0% and utilizing the maximum amount of available additional subsidization.

2. Maintain the CWSRF in perpetuity by adding repayment and investment interest to the Fund.

The State tracks fund balances that include interest revenue, principal repayments, and investment activity with the intent of maintaining the Fund in perpetuity. Annual increases in net position, no loans in default, a growing loan portfolio, and low expenses help to achieve this goal (Attachment 2).

At the end of SFY 2024, there were seventy-two loans in repayment (Attachment 5). Loan

repayments help provide funds that ensure a robust NM CWSRF program in perpetuity.

Cash balances are in US Treasury Bonds invested by the New Mexico State Treasurer's Office (NM STO).

3. Maintain the fiscal integrity of the CWSRF.

The NMED CWSRF is committed to transparency and accountability. In SFY 2024, the New Mexico Environment Department (NMED) contracted with CliftonLarsonAllen, LLP (CLA) to conduct the SFY 2024 financial and single audit. CLA provides performance recommendations, a formal opinion on the CWSRF's financial statements, and guidance on conformance federal requirements. NMED has completed the SFY 2024 draft financial statements (Attachment 2) for the CWSRF. The final CWSRF audit will be issued when the NMED completes the Agency audit and will then be sent to the EPA.

4. Encourage green projects by providing funding opportunities for eligible projects that support energy efficiency, water efficiency, green infrastructure, and environmental innovation.

The NMED CWSRF continues to encourage green investment in infrastructure. We have been particularly successful in energy efficiency and water efficiency projects given the abundance sunlight in the state and the lack of water. More information on the projects that were funded is provided below in the response to Short Term Goal 6.

5. Make funding available to potential borrowers who meet the criteria of one of the twelve CWSRF eligibilities found in 33 USC §1383 (c) of the CWA as amended and as it applies to New Mexico.

New Mexico's funding for SFY 2024 is comprised of

- 5 Wastewater Treatment Projects
- 3 Planning and assessment projects
- 1 Stormwater
- 1 Surface water protection
- 1 groundwater protection

The NMED CWSRF continues to work on expanding funding throughout New Mexico. In the last fiscal year, we specifically targeted the largest systems in the state, all of which have participated in the bond market for funding rather than pursuing CWSRF funding. The City of Las Cruces signed a loan for \$17 million, the City of Santa Fe has committed to a \$151 million dollar package for multiple projects, and the Albuquerque Bernalillo County Water Utility Authority has committed to a \$5 million reuse project.

6. Incorporate the BIL funding into the existing program.

NMED has incorporated Bipartisan Infrastructure Law funding into the CWSRF program.

7. Provide available additional subsidy to eligible entities with an emphasis on those entities that meet the affordability criteria.

In SFY2024, eleven new projects were funding, one did not receive additional subsidization, one did not meet affordability criteria but was awarded pursuant to the not subject to the CWA provisions, two entities (three projects) did not meet affordability criteria but were funded from emerging contaminant allocations, the other six entities met the affordability criteria.

8. Pursue funding scenarios as afforded by state statute to fully maximize lending opportunities.

We continue to work on fully utilizing the funding opportunities afforded by state statute. The additional interest in the program spurred by the passage of BIL, has focused on traditional projects.

- **B.** Short-term Goals for State Fiscal Year 2024
 - 1. Completion of the annual audit, the intended use plan, and the annual report in a timely manner. CWA Sec. 606 (b, c, d).

The NMED submitted the draft SFY 2024 IUP to the EPA on June 30, 2023.

NMED will meet with the submission of this report and the SFY 2024 audit.

- 2. Apply for available federal allotments as follows:
 - a. FFY 2023 BIL General Supplemental no later than June 15, 2023.
 - b. FFY 2023 CWSRF Base capitalization grant no later than September 30, 2023.
 - c. FFY 2023 BIL Emerging Contaminants no later than September 30,2023.

The NMED CWSRF applied for the BIL Supplement FFY2023 allotment on June 7, 2023; the CWSRF Base capitalization grant on December 18, 2023, and the Emerging Contaminant allotment on April 18, 2024

NMED met the goal for the General Supplemental grant but not for the other two grants.

3. Identify applicants that meet the state's affordability criteria.

The NMED CWSRF identified applicants that met the affordability criteria and awarded subsidy. (Attachment 3)

NMED met this goal.

4. Identify applicants from the SFY 2024 project priority list (PPL) to receive funding, including additional subsidization from all current funding sources. Award all available additional subsidy. (Attachment 3)

The NMED CWSRF received four capitalization grants in SFY 2024, the 2023 Base Grant, BIL-GS-2, and EC 1 and 2. NMED has awarded all funds from the BIL-GS 2, including additional subsidy. The FFY2023 Base grant lacks additional subsidization commitment of

\$133,267 to be fully obligated. NMED CWSRF has fully obligated the first emerging contaminant grant and obligated \$373,000 of \$1,043,000 for the FFY2023 Emerging Contaminant grant (EC2). Bernalillo County project CWSRF EC 136 will require an additional \$1.6 million to complete the project which will fully utilize EC2.

The NMED CWSRF recognizes the importance of fully utilizing all funds available including repayment funds. At the end of SFY2024, the Fund had a cash balance of \$201 million and expects principal and interest payments of \$14.1 million in SFY2025. The NMED CWSRF is currently executing projects totaling \$182,667,000. Additional applications are in the pipeline. Additionally, we are working to increase annual disbursements. Through a more targeted approach by our technical staff, and more assertive expectations of borrowers and their technical teams, we hope to focus more attention on timely spending. Table 1 shows the capitalization grant commitments.

NMED did not meet this goal.

5. Utilize the 2% technical assistance authorized by the BIL in conjunction with the Base capitalization grant and the BIL General Supplemental grant.

In SFY2024, NMED CWSRF fully executed an MOA with the UNM Southwest Environmental Finance Center to provide technical assistance to borrowers, however no assistance was provided in the fiscal year.

NMED did not meet this goal.

6. Identify green projects equal to no less than 10% of each funding allotment.

The NMED CWSRF signed four projects that will have green components: A Stormwater Outfall/Emerging Contaminant project for Bernalillo County, a Stormwater Master Plan for the Village of Ruidoso, and a reuse project for the City of Tucumcari. The Tucumcari project will be 100% green at \$3,210,000. NMED will assess the GPR value for the other projects when we have received more information. We also continue to work on multiple green projects in the pipeline, including solar installation at the Village of Ruidoso WWTP, flood control and green infrastructure construction for the City of Anthony, and stormwater mitigation for the City of Santa Fe.

NMED met this goal.

7. Complete the environmental benefits in the Clean Water Benefits Reporting System (CBR) quarterly.

The NMED enters environmental benefits into the Loan Grant Tracking System as executes each agreement, and then exports reports quarterly to the OWSRF site.

NMED met this goal.

8. Maintain or improve the State's average financial indicators reported to and compiled in the National Information Management System (NIMS).

The NM CWSRF continues to work on improving financial indicators.

- The Return on Investment, 168% is well below the 2023 national average of 303%.
 - o As expressed in short-term goal four, NMED will work to increase annual disbursements.
- Executed loans as a percentage of funds available increased by 1%, from 83% to 84%. The 2023 national cumulative average was 98.91%
 - o Long-term goal five discusses current loans that are being executed. These will immediately address this financial indicator next year, but NMED will need to sustain additional borrowers to address this long-term.
- Disbursements as a percentage of executed loans is 84%, down two percentage points from last year and below the 2023 national cumulative average by 4%.
 - o As noted in short-term goal four, the NMED intends to work to increase the pace of disbursements.
- Additionally, our ratio of undisbursed funds decreased to 9.4 years, but is well below EPA's desired benchmark of 5 years or less.

NMED did not meet this goal.

9. Pursue non-traditional financing options.

The NM CWSRF continues to pursue non-traditional financing options, but additional BIL funding has been more focused on traditional projects.

NMED did not meet this goal.

10. Execute binding commitments as required by each grant. BIL General Supplemental requires 110% of the grant, CWSRF Base requires 120%, and Emerging Contaminants requires 100%. NMED CPB accepts applications year-round and updates the Project Priority List quarterly.

The CWA requires binding commitments within one year of the federal award (payment). The BIL GS-2 award required binding commitments of \$11,256,300, no later than December 31, 2024; the commitment goal was achieved in August 2023. The required amount for the FFY2023 Base award is \$4,419,600 with commitments requirement by February 28, 2025. All commitments for this award will occur in SFY2025. (Attachment 1)

NMED partially met this goal in SFY2024 and will fully meet it in SFY2025.

CHANGES TO INTENDED USE PLAN and FUTURE GOALS

The NMED CPB revised the test of FY2024 IUP twice during the that fiscal year. In September 2023 NM CWSRF applied to transfer unused DWSRF Emerging Contaminant funding to the CWSRF and in April 2024 to apply for the FFY2023 Emerging Contaminant Grant.

The FY2025 Intended Use Plan has been prepared and published. Below are the long- and short-term goals for SFY2025.

A. Long-term Goals for State Fiscal Year 2025:

- 1. Provide local authorities, state agencies, interstate agencies and other qualified borrowers in New Mexico with low-cost financial assistance for the construction of wastewater facilities or other eligible water quality projects.
- 2. Maintain the CWSRF into perpetuity by managing fund outputs and including repayment and investment interest.
- 3. Maintain the fiscal integrity of the CWSRF by complying with state and federal financial management, accounting, auditing, and reporting requirements.
- 4. Annually meet the goal of 10% GPR for each funding allotment by promoting funding opportunities for eligible projects that support energy efficiency, water efficiency, green infrastructure, and environmental innovation.
- 5. Incorporate the BIL funding into the existing program.
- 6. Annually provide all available additional subsidy to eligible entities with an emphasis on those entities that meet the affordability criteria.

7. Pursue funding scenarios as afforded by state statute to fully maximize lending opportunities.

B. Short-term Goals for State Fiscal Year 2025:

- 1. Complete the annual audit, intended use plan and annual report in a timely manner.
- 2. Apply for available federal allotments as follows:
 - a. FFY 2024 BIL General Supplemental no later than August 1, 2024.
 - b. FFY 2024 CWSRF Base capitalization grant no later than December 1, 2024
 - c. FFY 2024 BIL Emerging Contaminants no later than December 1, 2024
- 3. Identify applicants that meet the state's affordability criteria.
- 4. Identify applicants from the SFY 2025 project priority list (PPL) to receive funding, including additional subsidization from all current funding sources.
- 5. Award all available additional subsidy.
- 6. Identify green projects equal to no less than 10% of each funding allotment.
- 7. Complete the environmental benefits in the Clean Water Benefits Reporting System (CBR) quarterly.
- 8. Maintain or improve the State's average of financial indicators that are reported and compiled in the National Information Management System (NIMS).
- 9. Execute binding commitments as required by each grant. BIL General Supplemental and the CWSRF Base requires 120%, and Emerging Contaminants requires 100%. NMED CPB accepts applications year-round and updates the Project Priority List quarterly.
- 10. Implement change in award of additional subsidization for eligible projects from grants to principal forgiveness to lessen the federal requirement burden on funding recipients.
- 11. Address timely and expeditious concerns, including over five years of disbursements by:
 - a. More consistent marketing and outreach with the new Marketing Coordinator position.
 - b. Utilizing Northbridge Environmental to help strategize building a consistent customer base
 - c. Establishing a lending relationship with at least one large municipality.

B. Administrative Portion

In SFY 2024 NMED used 1/5 percent of the valuation of the CWSRF fund (fund 12100) for the costs of administering the fund. As of June 30, 2022, the audited valuation (Total Net Position) of the CWSRF fund was \$361,325,034 allowing NMED to budget \$722,650 for administrative uses. The NM CWSRF expended \$527,046 from the Fund for administration.


C. CWSRF Administrative Fund Activity

The sole purpose of the Administrative Fund (fund 32700) is to support the administration of the Program so that it will function in perpetuity. At the beginning of SFY 2024, the cash balance of fund 32700 was \$5,632,600. The increase is due to the collection of administrative fees and overnight interest. The operating expenses charged to Fund 32700 include payroll, travel, computers, and other office expenses. The chart demonstrates the diminishing trend of administrative fees collected. This trend is due to the extremely low interest rate we are currently charging of 0.01%. This low rate does not include an administrative fee; this will be a consideration when determining the borrowing interest rate for FY2026.

Figure 5 shows the FYE 2024 fund balance, and the annual amount of fees collected and deposited in Fund 32700 from SFY 2015 through 2024.



D. Assistance Activity

The NM CWSRF signed eleven new loan/grant agreements in SFY 2024 totaling \$33,422,093 and amended8 existing agreements for \$6,563,000. For the purposes of tracking, interim loan execution dates represent project start dates (Attachment 3 and 6).



NMED had four project completions/initiation operations in SFY2024: Las Vegas CWSRF 071, Santa Rosa CWSRF 099, El Valle de Los Ranchos CWSRF 112, and the Village of Jemez Springs CWSRF 116. (Attachment 6)

E. Criteria and Method Established for Distribution of Funds (Title VI)

Pursuant to the Loan Act, the Water Quality Control Commission (WQCC) adopted regulations defining eligibility requirements for financial assistance, application procedures, priority ranking system and administration of the loan program and fund. The WQCC adopted the current priority ranking system on September 8, 2020.

NMED ground water, surface water and CPB staff reviewed all SFY2024 applications. Ground water and surface water staff review for the respective areas of expertise while CPB reviews for readiness to proceed and sustainability criteria.

NMED public noticed the Projects Priority List (PPL) through the NMED website, notification to the New Mexico Municipal League and the Association of Counties, notification to the Rural Community Assistance Corporation, the Rural Water Association, and to the CWSRF listserv through Granicus, a cloud-based email platform. NMED accepted public comments regarding the SFY 2024 Intended Use Plan (IUP) and associated PPL from June 12th through June 23rd, 2023, but received none.

A project must be on the current New Mexico state fiscal year PPL to receive a loan. It is the policy of NMED to make loans to entities in order of priority on the current fiscal year priority list to the extent reasonable considering the following:

- 1. Willingness of the entity to accept a loan.
- 2. Financial capability of the entity to service the loan.
- 3. The ability of the community to operate and maintain the proposed project.
- 4. Readiness to proceed.
- 5. Ability to meet 33 USC §CWA, Affordability Criteria

In addition to the above considerations, NMED CPB evaluates applicants' ability to meet 33 USC §1383 (i) CWA, Affordability Criteria. NMED CPB utilizes 100% of available additional subsidization to make projects as affordable as possible.

The NMED may choose to bypass, or skip, higher ranking projects for projects that are lower ranked but meet the above stated criteria. Projects that are bypassed and can demonstrate they are actively working to meet the criteria may stay on the list to receive future funding. Applicants are encouraged to discuss projects and financials with the NMED CPB team members prior to application. The NMED CPB team will provide guidance regarding eligibility, program requirements, and project/financial readiness. Priority List projects that were bypassed can be found in Attachment 7.

The New Mexico CWSRF reserves to the right to provide funding for projects which require immediate attention to protect public health on an emergency basis as declared by the Cabinet Secretary of the New Mexico Environment Department or by the Office of the Governor.

F. Water Quality Protection

The following table lists projects in progress with the NMED CWSRF and the projects anticipated results for the Improvement/Maintenance of Water Quality and the Contribution to Protection or Restoration for Designated Surface Waters. This information is in the Clean Water Benefits Reporting System (CBR).

G. Build America Buy America (BABA) Pub. L. No. 117-558, §§70901-52. The State certifies that for equivalency projects, all iron, steel, manufactured products, and construction materials used in the project are produced in the United States.

The NM CWSRF has processes in place to execute BABA requirements. Borrowers agree to follow the BABA requirements through the execution of the funding agreement. Additionally, the supplemental conditions contain compliance certifications that borrowers must complete throughout the project and a final compliance certification at project completion. There is currently one project subject to BABA provisions, Socorro CWSRF EQ 129. The project is currently in the design phase.

H. Provisions of the Operating Agreement/Condition of Grant Agreement.

EPA signed the Operating Agreement (OA) between the NMED and EPA on September 16, 2024. The OA provides certifications and assurances pertaining to:

Binding Commitments within One Year of grant payment: Sec. 602(b)(3). The State agrees to execute binding commitments with recipients to provide financial assistance from the CWSRF. The binding commitments shall be in an amount equal to the required amount based on the federal award.

The CWA requires binding commitments within one year of the federal award (payment). The BIL GS-2 award required binding commitments of \$11,256,300, no later than December 31, 2024; the commitment goal was achieved in August 2023. The required amount for the FFY2023 Base award is \$4,419,600 with commitments requirement by February 28, 2025. All commitments for this award will occur in SFY2025. (Attachment 1)

Loan Terms Sec. 603(d)(1)

In accordance with 603(d)(1) and the terms of the Operating Agreement, the state makes loans extending up to thirty (30) years. At the end of the interim loan agreement, the weighted useful life of each project is required to be submitted by the borrower. Borrowers can choose a repayment term that does not exceed the projected useful life or 30 years.

Additional Subsidization Sec. 603(i)(1)

In accordance with the terms of the Operating Agreement, the state certifies that it will provide additional subsidization to benefit a municipality that meets the established affordability criteria, or that does not meet the affordability criteria but meets the alternative criteria that is provided pursuant to the CWA. Affordability criteria identifies municipal entities with population decline, higher than average unemployment and lower than average per capita income. Municipal entities that qualify under the States affordability criteria are considered disadvantaged.

All additional subsidization is used to support projects that repair or replace existing infrastructure, reflect the full lifecycle costs of the project, the planning and or design for such projects, or otherwise demonstrate a water quality benefit.

Expeditious and Timely Expenditures: Sec. 602(b)(4).

EPA has asked for increased attention to the Expeditious and Timely clause of the CWA. The NM CWSRF has long struggled to find interested borrowers and has a high unobligated fund balance. The NM CWSRF has revised state statute to include all EPA approved eligibilities and broadened the definition of an eligible borrower. We have moved to a simple electronic application that is open year-round. In SFY2023 we lowered the borrowing interest rate to 0.01% for all public entities that do not qualify for 0%. We are currently contracting with Northbridge Environmental to help market the program, specifically to the large entities in the state. In SFY2024, Northbridge and NMED CWSRF representatives visited the Cities of Santa Fe, and Albuquerque, the Albuquerque Bernalillo County Water Authority (Authority), Bernalillo County, and the Albuquerque Metropolitan Arroyo Flood

Control Authority, all of whom bond to fund capital improvements. While all entities appreciated the low interest rates and flexibility of the program, most were skeptical of changing their funding practices. However, the City of Santa Fe did express interest, especially with the concept of utilizing programmatic financing. NMED CWSRF is currently working to execute a \$151 million dollar package for multiple projects. The Authority also submitted a \$5 million project as a trial. Bernalillo County was reticent to take any loan, but the NMED is funding two emerging contaminant 100% grant projects with the County. In SFY 2024 NMED CWSRF also signed our first project with the City of Las Cruces for \$17 million. It is our intent to parlay these new customers into repeat borrowers. The Sources and Uses table on page 12 shows, if our current packages in the commitment queue are fully executed, we will be looking at future cash flows to fund the program in the near future. Long-term funding at this level will require a fundamental change in the way the funds wastewater infrastructure. To that point, the New Mexico Legislature appropriated over \$40 million in 100% grant funding for 71 CWSRF eligible projects, for the same period we are reporting on. For the most part, no single appropriation was sufficient to address the significant needs, but they are enough to deter entities from borrowing. The recent Clean Watersheds Needs Survey documents that there are enough projects, but we must convince entities that it is in their best interest to take on low interest loans rather than waiting for future grant funding. The NM CWSRF will continue to promote the program to all eligible entities and to develop programs for non-traditional funding with the intent of signing new borrowers and retaining existing borrowers.

The other part of this equation is increasing annual disbursement expenditures. This will take prioritizing CWSRF work over other work in CPB and setting expectations as to the level of involvement and follow-up. With upcoming staffing changes, there is a significant opportunity to initiate new processes, expectations, and goals.

The NMED CWSRF will continue to work with Northbridge Environmental with marketing, outreach, and overall strategic planning.

Proportionality

Pursuant to the Memo: Approval of Class Exception for the Clean Water and Drinking Water State Revolving Fund Cash Draw Rules signed November 2022, states are not required to draw at proportional levels. The NMED CPB utilizes 100% of the required state match prior to utilizing any related capitalization grant funding.

NMED will add two additional projects, Estancia Valley Solid Waste for \$2,251,317 and Albuquerque Bernalillo County Water Authority for \$4,842,683.

For CS-350003-23, we will report the City of Gallup for the full amount of \$3,686,000.

Compliance with Federal Cross Cutting authorities:

In SFY2023 the NM CWSRF began a policy transition regarding the application of federal requirements. In previous years NMED applied federal requirements across all projects. With the advent of the Build America Buy America Act, the NM CWSRF determined it was in the best interest of borrowers to only apply federal requirements to projects reported in FFATA. NMED is continuing to transition through this process.

In accordance with 40 CFR, Part 33, Subpart D, compliance with the negotiated Disadvantaged Business Enterprise (DBE) "Fair Share" objectives:

The Biden administration reinstated Fair Share objectives effective FY2024. These objectives are in the supplemental conditions provided to equivalency borrowers and borrowers receiving additional subsidization in the form of a grant.

Legal, Managerial, Technical, and Operational Capabilities: The State certifies that it has the legal, managerial, technical, and operational capabilities to administer the Program competently.

Currently, the financial loan team has two vacant positions, with one position submitted for posting and the other submitted for a reclass to a higher pay band. The Technical staff has three vacancies; one is filled with a start date of mid-October and the other two positions are not advertised. The Bureau Chief position is also vacant but is advertised. CPB also created and filled a new accountant/auditor position to assist the loan team with financial reviews and reconciliations.

I. Justice 40

Justice40 is an interagency initiative led by the White House Envornmental Justice Interagency Council with the intent of ensuring that 40% of federal dollars are made available to communities identified as disadvantaged. In SFY2024, the NM CWSRF had \$15,418,000 in federal funds, of which 40% is \$6,167,200. The NM CWSRF committed \$32.6 million to disadvantaged communities with \$9.9 million coming directly from federal funds, exceeding the required amount.

V. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Clean Water State Revolving Fund - The Program utilizes an enterprise fund to provide low-cost financial assistance through loan and loan subsidy funding to eligible entities for planning, design, and construction of water quality projects. CWSRF funds are available for up to 100% of eligible costs. Loan repayment terms are up to 30 years with interest rates ranging from 0% to

2.375%.

VI. ACCRUED INTEREST RECEIVABLE ON CONSTRUCTION LOANS

CWSRF loans accrue interest during the construction period. At the end of construction, the Borrower may capitalize the interest or pay the interest up front.

VII. DISCUSSION OF ADMINISTRATIVE REIMBURSEMENT PROCESS

In accordance with Section 603(d)(7) of the CWA, monies in the CWSRF may be utilized for the reasonable costs of administering the fund and conducting activities under this title. NMED budgeted 1/5 percent of the most recent valuation of the fund, plus the amount of any fees collected by the State for such purpose regardless of the source.
