### Introduction

The Construction Programs Bureau (CPB) directly manages three funding sources: Capital Outlay Appropriations (CO), the Clean Water State Revolving Loan Fund Program (CWSRF), and the Rural Infrastructure Program (RIP). CPB engineering staff provide technical oversight for these funding programs. CPB serves 224 communities throughout New Mexico, with 480 total projects. Nearly \$67 million was disbursed from the directly managed programs in 2024.

CPB strives to ensure projects are sustainable, environmentally sound, completed on time, and free of waste, fraud, and abuse.





#### CWSRF as of 12/31/2024




#### RIP as of 12/31/2024

## Clean Water State Revolving Fund

The Clean Water State Revolving Fund (CWSRF) provides low-interest rate loans for a wide range of water quality projects, including wastewater treatment, stormwater, reuse, water conservation, and nonpoint source projects. The CWSRF receives annual capitalization grants from the US Environmental Protection Agency. Currently, public entities have two interest rates: 0% or 0.01% depending on financial eligibility. Loan terms are up to thirty years. Applications for CWSRF funding are accepted year-round. Funding must be reimbursed and loan repayment begins one year after project completion. In 2024, the CWSRF provided funding for 17 new and amended projects, totaling \$43.3 million, and awarded \$9.3 million in subsidy.

New to the Clean Water State Revolving Fund, is Emerging Contaminant (EC) funding available through the Bipartisan Infrastructure Law (BIL). EC funding is 100% principal forgiveness and can fund various projects addressing emerging contaminants, including perfluoroalkyl and polyfluoroalkyl substances (PFAS), in wastewater, stormwater, and nonpoint source pollution.

In 2024, the CWSRF signed three planning and design agreements with communities. Planning and design projects provide communities with a solid base to initiate infrastructure construction projects. The other 14 loans included wastewater infrastructure construction, stormwater infrastructure, or modeling and analysis to address emerging contaminants. In 2024, CPB amended six loans to increase funding by a total of \$6.5 million, and 21 loans to extend the time for the project. Projects are delayed due to a lack of engineering consultants and long lead times on equipment and materials for construction projects.

As of December 31, 2024, the CWSRF had 41 active loans with an undisbursed balance of \$104.9 million and 72 loans in repayment with a balance due of \$142.4 million.

## **CWSRF Highlighted Project:**

## City of Santa Rosa Wastewater Treatment Plant Solar Project CWSRF 119

The City of Santa Rosa received \$736,340 from the Clean Water State Revolving Fund (CWSRF) program to design and construct a net-metered ground-mounted fixed-tilt 310 kilowatts (kW) solar photovoltaic system at the City's wastewater treatment plant (WWTP). The system will save the City approximately \$49,680 per year in electric utility costs. The repayment for the loan, at 0% interest for 30 years, will be \$24,545 annually. The project provides green, renewable, more affordable and locally-sourced energy, while simultaneously stabilizing utility rates.

## **CWSRF Highlighted Project:**

## City of Roswell Wastewater Treatment Plant CWSRF 097

The City of Roswell Wastewater Treatment Plant (WWTP), located in Chaves County, has performed major upgrades primarily in the liquid treatment process since 2008. The City now aims to improve the solid treatment process, which previously consisted of using sludge drying beds that have been in use since the 1980s to create Class A fertilizer, which can be used on parks and golf courses. Insufficient bed space during the winter has made it necessary to enhance this process, as the beds are at full capacity and the city has had to utilize the compost bed for additional drying.

The City of Roswell received \$9.7 million funded by the Clean Water State Revolving Loan Fund (CWSRF), to improve this solid treatment process. This project includes the construction of a dewatering building with screw presses, the installation of new digested sludge feed pumps and polymer units, and the creation of a digested sludge feed system. Project completion is expected in early 2025.

## Rural Infrastructure Program

The Rural Infrastructure Program (RIP) provides financial assistance for water, wastewater, and solid waste projects. RIP funds mutual domestic water consumer associations, water and sanitation districts, municipalities serving populations of less than 20,000, and counties with less than 200,000 people. Assistance is available for project planning, design, and construction. Loans are repaid with payments starting one year after project completion. This program can provide a quick turn-around time with loans finalized in 6-8 weeks if the borrower can meet the requirements. The flexibility of the RIP program also makes it a go-to funding source when other funding sources cannot close the gap. Currently, the RIP program provides supplemental funding for Los Alamos County and Belen to supplement Drinking Water State Revolving Fund projects that were under funded. The RIP program has also recently funded two projects with the NM Department of Transportation (NMDOT). These projects can complete water and sewer line replacement projects while NMDOT also has its own planned road projects. The Village of Red River completed water line replacements in conjunction with NMDOT work and the Town of Mesilla is currently replacing both water and sewer lines.

In 2024, there were 13 new loans executed for a total of \$4.3 million in funding and, one loan amended to increase the funding by \$75,000.

As of December 31, 2024, RIP had 14 active loans with an undisbursed balance of \$4.9 million and 70 loans in repayment with a balance due of \$18.2 million.

### **RIP Highlighted Project:**

## **City of Belen Vactor Truck Purchase RIP 00043**

The City of Belen in Valencia County has received \$600,000 from the Rural Infrastructure Loan Program to purchase a new Vactor truck for their utility operations, covering most of the purchase costs. This acquisition includes a 2024 Vactor 2115i mounted on a 2025 Kenworth T880 6x4 chassis with 370 horsepower. City Personnel also received training, ensuring they are properly equipped to operate this specialized truck. This essential equipment allows the city to maintain and service its water and wastewater infrastructure more effectively. The Vactor truck is equipped with modern features and capabilities. It means city crews can perform critical maintenance tasks, clean sewer lines, and respond to emergencies. This investment will help the City of Belen improve its infrastructure maintenance capabilities and provide better service to its residents.



## **RIP Highlighted Project:**

## Red River's Water Line Replacement RIP 00038

The Town of Red River, located in Taos County, needed to replace portions of its water distribution system in the downtown area. The Town received \$1.74 million loan funded by the Rural Infrastructure Program (RIP) in July 2022 for expenses to design and construct a waterline replacement project. This project included nearly one mile of waterline replacement downtown. Located in the downtown area, complications with sequencing work, and providing safety measures for workers and the public were important aspects of this project. The project was successfully completed and closed early 2024.

### **Capital Outlay Program**


Capital Outlay (CO) and Special Appropriations (SAP) consists of state grants for infrastructure projects that are appropriated by the New Mexico Legislature and approved by the Governor. Funds are distributed through assigned state agencies.

Water, wastewater, solid waste, or other environmental infrastructure projects are routinely assigned to the Environment Department Construction Programs Bureau (CPB). CPB provides administrative support per DFA Capital Outlay Bureau guidelines and technical support to the grantees through a staff of engineers.

The 2024 Legislature assigned CPB 133 new CO projects valued at \$58.9 million and 24 re-authorizations valued at \$4 million. The new capital outlay projects were funded using a general fund and the re-authorizations were a combination of general fund and severance tax fund.

As of December 31, 2024, CPB performed administrative and technical oversight for 481 CO and SAP projects with an appropriated value of \$231 million and a remaining balance of \$168 million. From January 1, 2024, through December 31, 2024, CPB closed 76 projects valued at \$30.1 million and executed 123 grant agreements valued at \$52 million. In calendar year 2024, CPB processed 676 capital outlay disbursements totaling \$45.3 million.

## **CO Highlighted Project:**

## Village of Magdalena Trujillo Well Replacement Project: 5132-DW and 24-I2461-GF

The Village of Magdalena received \$1,000,000 from the Drinking Water State Revolving Loan Fund to drill and equip a new well next to the Trujillo Well, along with \$370,000 from capital outlay to supplement the well-equipping work. The Trujillo Well is over 45 years old, and has experienced several hole collapses that have limited the pump installation depth. The new well will provide a more reliable water source to the community.

## **CO Highlighted Project:**

Eastern New Mexico Water Utility Authority Water Pipeline Projects: 22-G1047-GF HB2 (\$10 million), 5860-DW (\$32 million), 5861-DW (\$15 million), 22-G2420-STB (\$20 million), WTB-5667 (\$14.51 million), WTB-5952 (\$13.9 million), and WTB-6275 (\$20 million)

The Eastern New Mexico Water Utility Authority has been funded \$125.4 million to develop a pipeline and water treatment system for Clovis, Portales, Texico, Elida, Cannon Air Force Base, and various additional Roosevelt and Curry Counties areas. The cost is shared by the Federal Government (75%), the State of New Mexico (15%), and the member communities (10%). The pipeline will draw up to 16,415 acre-feet (over 5 billion gallons) of water annually from the Ute Reservoir in Quay County, pump the water to treatment facilities and tanks, and shore up the water supply from the Ogallala Aquifer.

# Sewer Overflow and Storm Reuse Municipal Grants Program

The Construction Programs Bureau participates in the Sewer Overflow and Stormwater Reuse Municipal Grant Program (OSG). This is an EPA Grant program, signed into law with America's Water Infrastructure Act of 2018, which re-authorized section 221 of the Federal Water Pollution Control Act (also known as the Clean Water Act or CWA). This grant is intended to address combined sewer overflows, sanitary sewer overflows, and stormwater management by making grants to states, who then make sub-awards to eligible entities for available projects.

The OSG program is closely aligned with the Clean Water State Revolving Fund in terms of federal requirements and project eligibility. Additionally, qualifying OSG projects on the CWSRF Intended Use Plan (IUP) are prioritized for OSG funding, as are projects for financially distressed communities and projects implementing long-term sewer overflow control plans.

The Village of Jemez Springs was awarded \$230,370 in 2024 to fund the wastewater treatment plant design and collection system. The design is ongoing.
