
## NO-COST TRAINING AND TECHNICAL ASSISTANCE

You can take **NO-COST** Safe Drinking Water Act (SDWA) compliance training right in your own state.

The Texas A&M Engineering Extension Service (TEEX) is offering small drinking water systems compliance training through an Environmental Protection Agency (EPA) Small Drinking Water Systems Training and Technical Assistance

Grant. This grant-funded training provides small drinking water systems (less than 10,000 population) with training and technical assistance to help comply with and/or maintain compliance with the SDWA.
