Amendments to the Hazardous Waste Regulations 20.4.2 and 20.4.3 NMAC. Christal Weatherly and Andrew Knight, NMED Office of General Counsel. The Environmental Improvement Board may render a decision following the

hearing. Time estimate: 5 1/2 hours.

Member Bitzer was scheduled to arrive late, so the board elected a different member to serve as Hearing Officer. Member Garcia moved for Chair Volkerding to serve as Hearing Officer. Member Suina seconded the motion. The chair called a voice vote. The motion passed unanimously.

Hearing Officer Volkerding provided an explanation of the hearing process. Board Administrator Martinez entered written public comment exhibits into evidence.

Christal Weatherly; NMED Assistant General Counsel, Andrew P. Knight; NMED Assistant General Counsel, David Cobrain; Hazardous Waste Bureau, and Janine Kraemer; Hazardous Waste Bureau gave an opening statement and provided their technical testimony. They were cross examined as a panel by the Board and Mr. Charles de Saillan; Counsel for Nuclear Watch New Mexico.

Joni Arends of the Concerned Citizens for Nuclear Safety permitted to provide public comment related to the petition prior to presentation of additional technical testimony due to her having to leave.

Sandy Blalock of the Automotive Recyclers Association was permitted to provide public comment related to the petition prior to presentation of additional technical testimony due to her having to leave.

Major Jodi M. Velasco; United States Air Force Regional Counsel, and Dr. Mahalingam Ravichandran; Department of Defense Regional Environmental Coordinator gave an opening statement and provided their technical testimony. Andrew Knight; NMED Assistant General Counsel, and David Cobrain; Hazardous Waste Bureau provided rebuttal technical testimony. They were cross examined by the Board. Major Jodi M. Velasco; United States Air Force Regional Counsel, and Dr. Mahalingam Ravichandran; Department of Defense Regional Environmental Coordinator provided sur-rebuttal technical testimony.

Charles deSaillan provided a public statement and entered a corresponding written public statement into the record.

Public Comment was invited. John Kieling offered his public comment.

NMED and Charles deSaillan provided their closing remarks.

Board Administrator entered additional written public comment exhibits into evidence. The sign-in sheet was also entered into evidence as an exhibit.
