MANUFACTURER: Fresca Foods, Louisville, Colorado.

RECALLED BY: Justin's Nut Butter, Boulder, Colorado.

DISTRIBUTION: Grocery and specialty food stores throughout New Mexico. See attached distribution list for specifics.

QUANTITY: Unknown.

REASON: The specific lots of Justin's peanut butter products are being voluntarily recalled because peanuts possibly used in the production of these identified products may have the potential to be contaminated with Salmonella, an organism that can cause serious and sometimes fatal infections in young children, frail or elderly people, and those with weakened immune systems.
