**QUANTITY:** Unknown

**REASON:** The products have the potential to be contaminated with Salmonella, which is an organism that can cause serious and sometimes fatal infections in young children, frail or elderly people, and those with weakened immune systems.

**ADDITIONAL INFO:** The recall includes raw and roasted whole peanuts, both in-shell and shelled, which are within their current shelf life or have no stated expiration date.

- The roasted and roasted/salted peanuts being recalled will have best by/expiration dates on the packaging from October 12, 2012 through April 12, 2013.
- The raw peanuts being recalled (shelled and in-shell) will have either best by dates from October 12, 2012 through October 12, 2013 on the packaging, or a “Crop Year” marking on the package of 2011 or 2012, up to and including October 12, 2012.
