Attention: Food Establishments that are Permitted by the New Mexico Environment Department

***Certain Provisions of the Revised Food Rules that were Adopted in 2016
now have their Implementation Period Extended to March 1, 2018***

The New Mexico Environment Department's Environmental Health Bureau announces that the requirement for obtaining the Food Handler Card and Certified Manager Certification will be extended for one year. The effective date for complying with these requirements will be **March 1, 2018**.

This extension will ensure that NMED-permitted food establishments across the state are able to meet the requirements. In addition, the NMED will continue its dialogue with food establishments and industry to address questions and concerns regarding the Food Handler Card and Certified Manager Certification requirements, and to modify these provisions as necessary.
