REASON: The strain of *Salmonella* Heidelberg in question is identical to that of an outbreak of Salmonellosis that resulted in an [August 3, 2011 recall](#) of ground turkey products.

ADD'L INFO: The products subject to recall today bear the establishment number "P-963" inside the USDA mark of inspection. The products were produced on August 23, 24, 30 and 31 of this year.

NMED ACTION: Respond to any consumer complaints. Verify removal of product from retail locations.
