

GROUND WATER DISCHARGE PERMIT RENEWAL
Santa Fe Skies RV Park, DP-1092

I. INTRODUCTION

The New Mexico Environment Department (NMED) issues this Discharge Permit Renewal (Discharge Permit), DP-1092, to Browncastle Ranch, Inc. (permittee) pursuant to the New Mexico Water Quality Act (WQA), NMSA 1978 §§74-6-1 through 74-6-17, and the New Mexico Water Quality Control Commission (WQCC) Regulations, 20.6.2 NMAC.

NMED's purpose in issuing this Discharge Permit, and in imposing the requirements and conditions specified herein, is to control the discharge of water contaminants from the Santa Fe Skies RV Park (facility) into ground and surface water, so as to protect ground and surface water for present and potential future use as domestic and agricultural water supply and other uses and protect public health. In issuing this Discharge Permit, NMED has determined that the requirements of Subsection C of 20.6.2.3109 NMAC have been met.

The activities which produce the discharge, the location of the discharge, and the quantity, quality and flow characteristics of the discharge are briefly described as follows:

Up to 8,000 gallons per day (gpd) of domestic wastewater from the RV Park is discharged to two package treatment plant systems operating alternately or in parallel. Treated wastewater is disinfected and disposed of via subsurface drip irrigation to 7.02 acres. The discharge contains water contaminants or toxic pollutants which may be elevated above the standards of Section 20.6.2.3103 NMAC. The facility is located at 14 Browncastle Ranch, four miles southwest of Santa Fe, in Section 25, T16N, R08E, Santa Fe County. Ground water most likely to be affected is at a depth of approximately 180 feet and has a total dissolved solids concentration of approximately 250 milligrams per liter.

The original Discharge Permit was issued on September 4, 1996 and subsequently renewed and/or modified on March 17, 2004. The permittee's application consists of the materials submitted by the permittee dated March 16, 2009 and other materials as applicable. The discharge shall be managed in accordance with all conditions and requirements of this Discharge Permit.

Pursuant to Section 20.6.2.3109 NMAC, NMED reserves the right to require a Discharge Permit Modification in the event NMED determines that the requirements of 20.6.2 NMAC are being or may be violated or the standards of Section 20.6.2.3103 NMAC are being or may be violated. This may include a determination that structural controls and/or management practices approved under this Discharge Permit are not protective of ground water quality, and that more stringent requirements to protect and/or remediate ground water quality may be required by NMED. These requirements may include: expanding land application areas; changing waste management practices; expanding monitoring requirements; installing an advanced treatment system; and/or implementing abatement of water pollution.

Issuance of this Discharge Permit does not relieve the permittee of the responsibility to comply with the WQA, WQCC Regulations, and any other applicable federal, state and/or local laws and regulations, such as zoning requirements and nuisance ordinances.

II. FINDINGS

In issuing this Discharge Permit, NMED finds:

1. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move directly or indirectly into ground water within the meaning of Section 20.6.2.3104 NMAC.
2. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move into ground water of the State of New Mexico which has an existing concentration of 10,000 milligrams per liter or less of total dissolved solids within the meaning of Subsection A of 20.6.2.3101 NMAC.
3. The discharge from the facility is not subject to any of the exemptions of Section 20.6.2.3105 NMAC.

III. CONDITIONS

The following conditions shall be complied with by the permittee and are enforceable by NMED. The permittee is authorized to discharge water contaminants subject to the following conditions:

OPERATIONAL PLAN

#	Terms and Conditions
1.	The permittee shall implement the following operational plan to ensure compliance with Title 20, Chapter 6, Parts 1 and 2 NMAC. [20.6.2.3106.C NMAC, 20.6.2.3107 NMAC]
2.	The permittee shall operate in a manner such that standards and requirements of Sections 20.6.2.3101 and 20.6.2.3103 NMAC are not violated. [20.6.2.3101 NMAC, 20.6.2.3103 NMAC]
3.	The permittee is authorized to discharge up to 8,000 gallons per day of domestic wastewater from the RV park that includes restrooms with showers and a five washer coin-op laundry to a wastewater treatment system. Wastewater gravity flows through a bar screen to two parallel surge tanks where the wastewater is mixed and aerated. Wastewater is then pumped to two sequential batch reactors (SBR) operating alternately or in parallel. Treated wastewater is pumped to an equalizer tank, conveyed to a secondary clarifier and then gravity flows to a settling/storage tank. Treated wastewater is then pumped through a UV disinfection system to a subsurface irrigation system for disposal to 7.02 acres within the RV park. Sludge from the SBR units and the clarifier is pumped to a sludge holding tank and transported off-site by a licensed hauler. [20.6.2.3104 NMAC, 20.6.2.3106 NMAC]
4.	The permittee shall discharge treated wastewater to 7.02 acres via a subsurface irrigation system. The amount of total nitrogen applied in the wastewater shall not exceed 200 pounds per acre per year. Nitrogen content shall not be adjusted to account for volatilization or mineralization processes. Wastewater shall be distributed evenly over the entire area of application. [20.6.2.3109 NMAC]
5.	The permittee shall maintain the existing wooden fencing and locked gate to limit public access to the wastewater treatment facility. The access controls shall be constructed in a manner which prevents access by the general public and animals such as dogs (e.g., chain link, field fencing or locking lids) and shall be maintained throughout the term of this Discharge Permit. [20.6.2.3109 NMAC]
6.	The permittee shall maintain signs at the facility entrance and other areas where public contact is possible indicating that the water is not potable. All signs shall remain visible and legible for the term of this Discharge Permit. [20.6.2.3109 NMAC]
7.	The permittee shall remove solids from the SBR units as needed, depending on process control testing such as: the 30-minute settleometer test, the Mixed Liquor Suspended Solids concentration or the Mean Cell Residence Time. The permittee shall remove solids from the clarifier as needed. The solids shall be pumped to the sludge holding tank, transported, and disposed of in accordance with all local, state, and federal (40 CFR Part 503) regulations. Records of solids disposal shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3109 NMAC]
8.	The permittee shall utilize operators, certified by the State of New Mexico at the appropriate level, to operate the wastewater treatment and disposal systems. All operations and maintenance of all or any part of the wastewater system shall be performed by, or under the direct supervision of, a certified operator. [20.7.4 NMAC]

9.	The permittee shall conduct the following monitoring, reporting, and other requirements listed below. [20.6.2.3107 NMAC]
10.	<p>METHODOLOGY - Unless otherwise approved in writing by NMED, the permittee shall conduct sampling and analysis in accordance with the most recent edition of the following documents:</p> <ul style="list-style-type: none"> a) American Public Health Association, Standard Methods for the Examination of Water and Wastewater (18th, 19th or current); b) U.S. Environmental Protection Agency, Methods for Chemical Analysis of Water and Waste; c) U.S. Geological Survey, Techniques for Water Resources Investigations of the U.S. Geological Survey; d) American Society for Testing and Materials, Annual Book of ASTM Standards, Part 31. Water; e) U.S. Geological Survey, et al., National Handbook of Recommended Methods for Water Data Acquisition; or f) Methods of Soil Analysis: Part 1. Physical and Mineralogical Methods and Part 2. 11.	<p>The permittee shall submit quarterly monitoring reports to NMED for the most recently completed quarterly period by the 1st of February, May, August and November of each year.</p> <p>Quarterly monitoring shall be performed during the following periods:</p> <ul style="list-style-type: none"> • January 1st through March 31st (first quarter) – due by May 1st; • April 1st through June 30th (second quarter) – due by August 1st; • July 1st through September 30th (third quarter) – due by November 1st; and • October 1st through December 31st (fourth quarter) – due by February 1st. <p>Monitoring requirements detailed in this Discharge Permit are summarized on the sheet titled <i>Summary of Required Actions, Monitoring and Reporting</i>. 12.	The permittee shall measure the monthly volume of treated wastewater discharged from the treatment system using a totalizing flow meter. The monthly meter readings and monthly discharge volumes shall be submitted to NMED in the quarterly monitoring reports. The flow meter shall be calibrated to within +/- 10% of actual flow and kept operational at all times. [20.6.2.3107 NMAC, 20.6.2.3109 NMAC]
13.	<p>In the event that the permittee has not permanently ceased discharging to the subsurface irrigation system within 24 months of the effective date of this Discharge Permit (by DATE), the permittee shall install one new monitoring well within 25 months of the effective date of this Discharge Permit (by DATE). The permittee shall install:</p> <ul style="list-style-type: none"> • One monitoring well (MW-1) located 20 to 50 feet hydrologically downgradient of the subsurface irrigation system.

	<p>The monitoring well location shall be approved by NMED prior to installation. The well shall be completed in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008. Construction and lithologic logs shall be submitted to NMED within 30 days of well completion. In the event the permittee has permanently ceased discharging to the subsurface irrigation system and provided closure documentation for NMED approval within 24 months of the effective date of this Discharge Permit (by DATE), the installation of a monitoring well shall not be required. 14.	<p>Following well development and no more than five days after installation of the new monitoring well required by this Discharge Permit, the permittee shall sample ground water in the new wells and analyze the samples for NO₃-N, TKN, TDS, and Cl. 15.	<p>Once installed, the permittee shall perform quarterly ground water sampling in one monitoring well and analyze the samples for NO₃-N, TKN, TDS, and Cl. The permittee shall sample:</p> <ul style="list-style-type: none">• MW-1, intended to be located hydrologically downgradient of the subsurface irrigation system. <p>Ground water sample collection, preservation, transport and analysis shall be performed according to the following procedure:</p> <ol style="list-style-type: none">a) measure the depth-to-ground water from the top of well casing to the nearest hundredth of a foot;b) purge three well volumes of water from the well prior to sample collection;c) obtain samples from the well for analysis;d) properly prepare, preserve and transport samples; and

16.	<p>The permittee shall sample treated wastewater from the settling/storage tank on a monthly basis and analyze the samples for NO₃-N and TKN. The permittee shall sample treated wastewater from the settling/storage tank on a quarterly basis and analyze the samples for TDS and Cl. Samples shall be properly prepared, preserved, transported and analyzed in accordance with the methods authorized in this Discharge Permit. Analytical results shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]</p>
17.	<p>The permittee shall complete land application data sheets (LADS) quarterly that document the amount of nitrogen applied to the subsurface irrigation system. The LADS (copy enclosed) shall reflect the nitrogen concentration from the most recent wastewater analysis and the measured discharge volumes for each month. The LADS shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]</p>
18.	<p>The permittee shall visually inspect the area above the subsurface irrigation system quarterly to ensure proper maintenance. Any conditions that indicate damage to the subsurface irrigation shall be corrected. Such conditions include, but are not limited to erosion damage, animal activity/damage or evidence of seepage. The permittee shall keep a log of the inspection findings and repairs made. [20.6.2.3107 NMAC]</p>
19.	<p>The permittee shall log RV site usage on a daily basis. A summary of the log shall be submitted in the quarterly monitoring reports. [20.6.2.3107 NMAC]</p>

20.	<p>In the event that monitoring indicates ground water standards are violated during the term of this Discharge Permit, upon closure of the facility or during post-closure monitoring, the permittee shall collect a confirmatory sample from the monitoring well within 15 days to confirm the initial sampling results. Within 15 days of confirmation of ground water contamination, the permittee shall submit to NMED a corrective action plan that proposes measures to mitigate damage from the discharge including, at a minimum, source control measures and an implementation schedule. The permittee may be required to abate water pollution pursuant to Sections 20.6.2.4000 through 20.6.2.4115 NMAC, if the corrective action plan will not result in compliance with the standards and requirements set forth in Section 20.6.2.4103 NMAC within 180 days of confirmation of ground water contamination. 21.	<p>In the event of a spill or release that is not authorized under this Discharge Permit, the permittee shall initiate the notifications and corrective actions as required in Section 20.6.2.1203 NMAC. The permittee shall take immediate corrective action to contain and remove or mitigate the damage caused by the discharge. Within 24 hours after discovery of the discharge, the permittee shall verbally notify NMED and provide the information</p>

	<p>required by Paragraph (1) of Subsection A of 20.6.2.1203 NMAC. Within 7 days of discovering the discharge, the permittee shall submit a written report to NMED verifying the oral notification and providing any additional information or changes. The permittee shall submit a corrective action report within 15 days after discovery of the discharge. [20.6.2.1203 NMAC]</p>
22.	<p>In the event NMED or the permittee identifies any other failures of the Discharge Permit or system not specifically noted herein, NMED may require the permittee to develop for NMED approval contingency plans and schedules to cope with the failures. [20.6.2.3107.A(10) NMAC]</p>
23.	<p>In the event that information available to NMED indicates that the well is not appropriately constructed to effectively monitor ground water quality, contains insufficient water to allow the collection of representative ground water samples, or is not completed in a manner that is protective of ground water quality, the permittee shall install a replacement well within 90 days of notification from NMED. Replacement well location shall be approved by NMED prior to installation and completed in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008. Construction and lithologic logs shall be submitted to NMED within 30 days of well completion.</p> <p>Upon completion of the replacement monitoring well, the monitoring well requiring replacement shall be properly plugged and abandoned. The well shall be plugged and abandoned in accordance with the abandonment details in the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008, and any applicable local, state, and federal regulations. 24.	<p>In the event that LADS show that the amount of nitrogen in wastewater applied exceeds 200 pounds per acre per year, the permittee shall submit a corrective action plan for the reduction of nitrogen loading to the subsurface irrigation area. The plan shall be submitted to NMED for approval within 90 days of the end of the monitoring period in which the exceedance occurred. 27.	<p>RECORD KEEPING - The permittee shall maintain a written record of any spills, seeps, and/or leaks of effluent, and of leachate and/or process fluids not authorized by this Discharge Permit. [20.6.2.3107.A NMAC]</p>
