

GROUND WATER DISCHARGE PERMIT RENEWAL AND MODIFICATION
Western Sky's RV Park, DP-45

I. INTRODUCTION

The New Mexico Environment Department (NMED) issues this Discharge Permit Renewal and Modification (Discharge Permit), DP-45, to Rosa Beltran (permittee) pursuant to the New Mexico Water Quality Act (WQA), NMSA 1978 §§74-6-1 through 74-6-17, and the New Mexico Water Quality Control Commission (WQCC) Regulations, 20.6.2 NMAC.

NMED's purpose in issuing this Discharge Permit, and in imposing the requirements and conditions specified herein, is to control the discharge of water contaminants from Western Sky's RV Park (facility) into ground and surface water, so as to protect ground and surface water for present and potential future use as domestic and agricultural water supply and other uses and protect public health. In issuing this Discharge Permit, NMED has determined that the requirements of Subsection C of 20.6.2.3109 NMAC have been met.

The activities which produce the discharge, the location of the discharge, and the quantity, quality and flow characteristics of the discharge are briefly described as follows:

Up to 8,000 gallons per day (gpd) of domestic wastewater is discharged from 71 Recreation Vehicle (RV) hookups, a restroom and laundry facility, one apartment and two mobile homes to two septic tank/leachfield systems. The modification consists of adding two mobile homes and increasing the discharge volume from 7,000 to 8,000 gpd. The discharge contains water contaminants or toxic pollutants which may be elevated above the standards of Section 20.6.2.3103 NMAC. The facility is located at 16201 Las Alturas Drive, approximately two miles east of Vado, in Section 21, Township 25 South, Range 03 East, Dona Ana County. Ground water most likely to be affected is at a depth of approximately 85 feet and has a total dissolved solids concentration of approximately 1,000 milligrams per liter.

The original Discharge Permit was issued on January 29, 1979 and subsequently renewed and/or modified on January 24, 1984, June 7, 1990, July 30, 1996 and April 10, 2002. The permittee's application consists of the materials submitted by the permittee dated February 23, 2007. The discharge shall be managed in accordance with all conditions and requirements of this Discharge Permit.

Pursuant to Section 20.6.2.3109 NMAC, NMED reserves the right to require a Discharge Permit Modification in the event NMED determines that the requirements of 20.6.2 NMAC are being or may be violated or the standards of Section 20.6.2.3103 NMAC are being or may be violated. This may include a determination that structural controls and/or management practices approved under this Discharge Permit are not protective of ground water quality, and that more stringent requirements to protect and/or remediate ground water quality may be required by NMED. These requirements may include: expanding disposal areas; changing waste management practices; expanding monitoring requirements; installing an advanced treatment system; and/or implementing abatement of water pollution.

Issuance of this Discharge Permit does not relieve the permittee of the responsibility to comply with the WQA, WQCC Regulations, and any other applicable federal, state and/or local laws and regulations, such as zoning requirements and nuisance ordinances.

II. FINDINGS

In issuing this Discharge Permit, NMED finds:

1. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move directly or indirectly into ground water within the meaning of Section 20.6.2.3104 NMAC.
2. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move into ground water of the State of New Mexico which has an existing concentration of 10,000 milligrams per liter or less of total dissolved solids within the meaning of Subsection A of 20.6.2.3101 NMAC.
3. The discharge from the facility is not subject to any of the exemptions of Section 20.6.2.3105 NMAC.

III. CONDITIONS

The following conditions shall be complied with by the permittee and are enforceable by NMED. The permittee is authorized to discharge water contaminants subject to the following conditions:

OPERATIONAL PLAN

#	Terms and Conditions
1.	The permittee shall implement the following operational plan to ensure compliance with Title 20, Chapter 6, Parts 1 and 2 NMAC. [20.6.2.3106.C NMAC, 20.6.2.3107 NMAC]
2.	The permittee shall operate in a manner such that standards and requirements of Sections 20.6.2.3101 and 20.6.2.3103 NMAC are not violated. [20.6.2.3101 NMAC, 20.6.2.3103 NMAC]
3.	The permittee is authorized to discharge up to 8,000 gpd of domestic wastewater from 71 Recreation Vehicle (RV) hookups, a restroom and laundry facility, one apartment and two mobile homes to two septic tank/leachfield systems. Wastewater from the restroom and laundry facility is discharged to a 1,000 gallon capacity septic tank and disposed to a 800 square foot leachfield (East System). Wastewater from 71 RV hookups, an apartment and two mobile homes is discharged to a 37,000 gallon capacity septic tank and disposed to a 2,100 square foot leachfield (West System). [20.6.2.3104 NMAC, 20.6.2.3106 NMAC]
4.	To address the violation of ground water standards at the Western Sky's RV Park, the permittee shall submit the following documents to NMED within 90 days of the effective date of this Discharge Permit (by date): a) A Corrective Action Plan to address ground water contamination which shall include proposed measures to mitigate damage from the discharge including, at a minimum, source control measures and implementation schedule to address the ground water contamination. Examples of suitable source control measures include: the installation of an alternative wastewater treatment system to further reduce the total nitrogen in the treated wastewater, installation of an alternative disposal system or connecting to the Mesquite municipal sewage collection system. b) Construction plans, specifications, supporting design calculations and a schedule of implementation for the proposed measures. The plans and specifications for any proposed treatment and disposal system changes shall be certified by a licensed New Mexico professional engineer. c) In the event the Corrective Action Plan proposes an alternative on-site wastewater treatment or disposal system, a proposed location for a new monitoring well hydrologically downgradient and within 20-50 feet of a proposed treatment and disposal system or alternative disposal system shall be submitted. The monitoring well location shall be approved by NMED prior to installation. The well shall be completed in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i> , Revision 1.0, July 2008. Construction and lithologic logs shall be submitted to NMED within 30 days of well completion. d) The Corrective Action Plan shall be implemented within 30 days of NMED approval. [20.6.2.3107 NMAC, 20.6.2.3109 NMAC]
5.	Within 90 days of the effective date of this Discharge Permit (by date), the permittee shall provide access to the 1,000 gallon capacity septic tank serving the restroom and laundry

	<p>facility (East System) by installing two 24-inch openings unless the septic tank is to be removed as part of the Corrective Action Plan. The access openings shall be located above the inlet and outlet piping of the septic tank to facilitate inspection of the tank's interior, repair of the internal piping and removal of sludge and scum. The access openings shall be extended from the tank to at least three inches above the ground surface or as approved by NMED. The access openings shall have a secured lid to deter unauthorized access but the lid shall remain above ground, unconcealed by dirt or pavement. A secure lid shall consist of one of the following: a padlock; a twist lock cover requiring special tools for removal; a cover weighing 58 pounds or more, net weight; or a stainless steel hinge and hasp mechanism.</p> <p>[20.6.2.3107 NMAC]</p>

7.	<p>METHODOLOGY - Unless otherwise approved in writing by NMED, the permittee shall conduct sampling and analysis in accordance with the most recent edition of the following documents:</p> <ol style="list-style-type: none"> a) American Public Health Association, Standard Methods for the Examination of Water and Wastewater (18th, 19th or current); b) U.S. Environmental Protection Agency, Methods for Chemical Analysis of Water and Waste; c) U.S. Geological Survey, Techniques for Water Resources Investigations of the U.S. Geological Survey; d) American Society for Testing and Materials, Annual Book of ASTM Standards, Part 31. 8.	<p>The permittee shall submit quarterly monitoring reports to NMED for the most recently completed quarterly period by the 1st of February, May, August and November each year.</p> <p>Quarterly monitoring shall be performed during the following periods:</p> <ul style="list-style-type: none"> • January 1st through March 31st (first quarter) – due by May 1st; • April 1st through June 30th (second quarter) – due by August 1st; • July 1st through September 30th (third quarter) – due by November 1st; and • October 1st through December 31st (fourth quarter) – due by February 1st. <p>Monitoring requirements detailed in this Discharge Permit are summarized on the sheet titled <i>Cover Page for Discharge Permit Monitoring Reports</i>. The monthly meter readings, calculated water usage, notes and estimated volume of wastewater discharged shall be submitted to NMED in the quarterly monitoring reports. 10.	<p>Once prior to the expiration date of this Discharge Permit, NMED shall have the option to require the permittee to temporarily remove the dedicated pump (if so equipped) from each monitoring well to provide access for a complete well inspection by NMED personnel. NMED shall establish the inspection date and provide at least 60 days notice to the permittee by certified mail. Dedicated pumps shall be removed at least 48 hours prior to NMED inspection to allow adequate settling time for sediment agitated from pump removal.</p> <p>[20.6.2.3107 NMAC]</p>
11.	<p>In the event a new monitoring well is installed as required by the approved Corrective Action Plan, following well development and no more than five days after installation of the new monitoring well required by this Discharge Permit, the permittee shall sample ground water from the new monitoring well 4 (MW-4) and analyze the samples for NO₃-N, TKN, Cl, and TDS. The permittee shall sample:</p> <ul style="list-style-type: none"> • MW-4, intended to be located hydrologically downgradient and within 20-50 feet of a proposed treatment and disposal system or alternative disposal system. <p>Ground water sample collection, preservation, transport and analysis shall be performed according to the following procedure:</p> <ol style="list-style-type: none"> a) measure the depth-to-ground water from the top of well casing to the nearest hundredth of a foot; b) purge three well volumes of water from the well prior to sample collection; c) obtain samples from the well for analysis; d) properly prepare, preserve and transport samples; and e) analyze samples in accordance with the methods authorized in this Discharge Permit. <p>Depth-to-water measurements, analytical results, including the laboratory QA/QC summary report, and a facility layout map showing the location and number of each well shall be submitted to NMED within 45 days of the installation of the monitoring well.</p> <p>[20.6.2.3107 NMAC]</p>
12.	<p>The permittee shall survey all wells approved by NMED for Discharge Permit monitoring purposes to a U.S. Geological Survey (USGS) or other permanent benchmark. The survey shall be performed within 30 days of installing the new monitoring well 4 (MW-4), if this</p>

	<p>well is required by the approved Corrective Action Plan, or within 30 days of approval of the Corrective Action Plan if a new monitoring well is not required by the approved Corrective Action Plan. Survey data shall include northing, easting and elevation to the nearest hundredth of a foot or in accordance with the "Minimum Standards for Surveying in New Mexico" (12.8.2 NMAC). A survey elevation shall be established at the top-of-casing, with a permanent marking indicating the point of survey. The survey shall be completed and certified by a licensed New Mexico professional surveyor. Depth-to-water shall be measured to the nearest hundredth of a foot in all surveyed wells, and the data shall be used to develop a map showing the location of all monitoring wells and the direction and gradient of ground water flow at the facility. The data and map of ground water flow direction at the facility shall be submitted to NMED within 30 days of survey completion.</p> <p>[20.6.2.3107 NMAC]</p>
13.	<p>The permittee shall perform quarterly ground water sampling in up to four monitoring wells and analyze the samples for NO₃-N, TKN, Cl, and TDS. The permittee shall sample:</p> <ul style="list-style-type: none"> • MW-1, intended to be located hydrologically upgradient of the facility and approximately 100 feet northwest of the large RV septic tank/leachfield system (West System); • MW-2, intended to be located hydrologically downgradient and approximately 20 feet southwest of the large RV septic tank/leachfield system (West System); • MW-3, intended to be located hydrologically downgradient and approximately 20 feet south of the large 2,100 square foot leachfield serving the large RV septic tank/leachfield system (West System); and • MW-4 (if installed) intended to be located hydrologically downgradient and within 20-50 feet of a proposed treatment and disposal system or alternative disposal system. <p>Ground water sample collection, preservation, transport and analysis shall be performed according to the following procedure:</p> <ol style="list-style-type: none"> a) measure the depth-to-ground water from the top of well casing to the nearest hundredth of a foot; b) purge three well volumes of water from the well prior to sample collection; c) obtain samples from the well for analysis; d) properly prepare, preserve and transport samples; and e) analyze samples in accordance with the methods authorized in this Discharge Permit. <p>Depth-to-water measurements, analytical results, including laboratory QA/QC summary report, and a facility layout map showing the location and number of each well shall be submitted to NMED in the quarterly monitoring reports.</p> <p>[20.6.2.3107 NMAC]</p>
14.	<p>The permittee shall sample wastewater from the 1,000 gallon capacity septic tank (East System) and 37,000 gallon capacity septic tank (West System) on an annual basis for TKN, TDS and Cl. Analytical results shall be submitted to NMED in the monitoring report due by August 1st of each year.</p> <p>[20.6.2.3107 NMAC]</p>
15.	<p>The permittee shall inspect the septic tanks semi-annually for the accumulation of scum and solids. In the event that the scum layer exceeds three inches or the settled solids occupy</p>

	50% of the tank or more, the contents of the tanks shall be pumped by a licensed hauler. The inspection records and pumping invoices shall be submitted to NMED in the monitoring reports due by August and February 1 st of each year. [20.6.2.3107 NMAC]
16.	The permittee shall visually inspect the area above each leachfield semi-annually to ensure proper maintenance. Any conditions that indicate damage to each leachfield shall be corrected. Such conditions include, but are not limited to erosion damage, animal activity/damage, woody shrubs, or evidence of seepage. The inspection records shall be submitted to NMED in the monitoring reports due by August and February 1 st of each year. [20.6.2.3107 NMAC]
17.	The permittee shall log the total number of RV sites rented on a daily basis. A summary of the log shall be submitted in the quarterly monitoring reports. The summary shall include the total number of sites rented for each month. [20.6.2.3107 NMAC]

CONTINGENCY PLAN

18.	In the event that monitoring indicates ground water standards are violated during the term of this Discharge Permit, upon closure of the facility or during post-closure monitoring, the permittee shall collect a confirmatory sample from the monitoring well within 15 days to confirm the initial sampling results. Within 15 days of confirmation of ground water contamination, the permittee shall submit to NMED a corrective action plan that proposes measures to mitigate damage from the discharge including, at a minimum, source control measures and an implementation schedule. The permittee may be required to abate water pollution pursuant to Sections 20.6.2.4000 through 20.6.2.4115 NMAC, if the corrective action plan will not result in compliance with the standards and requirements set forth in Section 20.6.2.4103 NMAC within 180 days of confirmation of ground water contamination. [20.6.2.1203 NMAC, 20.6.2.4105.A(8) NMAC]
19.	In the event of a spill or release that is not authorized under this Discharge Permit, the permittee shall initiate the notifications and corrective actions as required in Section 20.6.2.1203 NMAC. The permittee shall take immediate corrective action to contain and remove or mitigate the damage caused by the discharge. Within 24 hours after discovery of the discharge, the permittee shall verbally notify NMED and provide the information required by Paragraph (1) of Subsection A of 20.6.2.1203 NMAC. Within 7 days of discovering the discharge, the permittee shall submit a written report to NMED verifying the oral notification and providing any additional information or changes. The permittee shall submit a corrective action report within 15 days after discovery of the discharge. [20.6.2.1203 NMAC]
20.	In the event NMED or the permittee identifies any other failures of the Discharge Permit or system not specifically noted herein, NMED may require the permittee to develop for NMED approval contingency plans and schedules to cope with the failures. [20.6.2.3107.A(10) NMAC]
21.	In the event that information available to NMED indicates that a well(s) is not appropriately

	<p>constructed to effectively monitor ground water quality, contains insufficient water to allow the collection of representative ground water samples, or is not completed in a manner that is protective of ground water quality, the permittee shall install a replacement well(s) within 90 days of notification from NMED. Replacement well location(s) shall be approved by NMED prior to installation and completed in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008.
