

GROUND WATER DISCHARGE PERMIT RENEWAL AND MODIFICATION
Corrales Elementary School, DP-1099

I. INTRODUCTION

The New Mexico Environment Department (NMED) issues this Discharge Permit Renewal and Modification (Discharge Permit), DP-1099, to the Board of Education, Albuquerque Public Schools, (permittee) pursuant to the New Mexico Water Quality Act (WQA), NMSA 1978 §§74-6-1 through 74-6-17, and the New Mexico Water Quality Control Commission (WQCC) Regulations, 20.6.2 NMAC.

NMED's purpose in issuing this Discharge Permit, and in imposing the requirements and conditions specified herein, is to control the discharge of water contaminants from the Corrales Elementary School (facility) into ground and surface water, so as to protect ground and surface water for present and potential future use as domestic and agricultural water supply and other uses and protect public health. In issuing this Discharge Permit, NMED has determined that the requirements of Subsection C of 20.6.2.3109 NMAC have been met.

The activities which produce the discharge, the location of the discharge, and the quantity, quality and flow characteristics of the discharge are briefly described as follows:

Up to 13,300 gallons per day (gpd) of wastewater is discharged from Corrales Elementary School. Wastewater collects in two septic tanks (a 15,000 gallon tank and an 8,000 gallon tank) for solids settling prior to gravity flowing into two lift stations. Wastewater is pumped from the lift stations to a splitter box that distributes it into four synthetically lined constructed wetland cells equipped with aeration. Wastewater then flows through a level adjust manhole into a synthetically lined lagoon for storage followed by a leachfield for disposal. Two standby linear gravel infiltration galleries are available for wastewater disposal in the event of a failure of the other disposal options. The modification consists of including a synthetically lined lagoon for storing wastewater. The discharge contains water contaminants or toxic pollutants which may be elevated above the standards of Section 20.6.2.3103 NMAC. The facility is located at 200 Target Road, in Corrales, in Section 34, T12N, R3E, Sandoval County. Ground water most likely to be affected is at a depth of approximately ten feet and has a total dissolved solids concentration of approximately 500 milligrams per liter.

The original Discharge Permit was issued on September 24, 1996 and subsequently renewed and/or modified on January 14, 2002. The permittee's application consists of the materials submitted by Michael Stephens of Jeff Mortensen & Associates, Inc. on behalf of the permittee dated April 24, 2007, and additional information received on October 12, 2009. The discharge shall be managed in accordance with all conditions and requirements of this Discharge Permit.

Pursuant to Section 20.6.2.3109 NMAC, NMED reserves the right to require a Discharge Permit Modification in the event NMED determines that the requirements of 20.6.2 NMAC are being or may be violated or the standards of Section 20.6.2.3103 NMAC are being or may be violated. This may include a determination that structural controls and/or management practices approved under this Discharge Permit are not protective of ground water quality, and that more stringent requirements to protect and/or remediate ground water quality may be required by NMED. These requirements may include: relining the lagoon or wetland cells; expanding disposal areas;

changing waste management practices; expanding monitoring requirements; installing an advanced treatment system; and/or implementing abatement of water pollution.

Issuance of this Discharge Permit does not relieve the permittee of the responsibility to comply with the WQA, WQCC Regulations, and any other applicable federal, state and/or local laws and regulations, such as zoning requirements and nuisance ordinances.

II. FINDINGS

In issuing this Discharge Permit, NMED finds:

1. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move directly or indirectly into ground water within the meaning of Section 20.6.2.3104 NMAC.
2. The permittee is discharging effluent or leachate from the facility so that such effluent or leachate may move into ground water of the State of New Mexico which has an existing concentration of 10,000 milligrams per liter or less of total dissolved solids within the meaning of Subsection A of 20.6.2.3101 NMAC.
3. The discharge from the facility is not subject to any of the exemptions of Section 20.6.2.3105 NMAC.

III. CONDITIONS

The following conditions shall be complied with by the permittee and are enforceable by NMED. The permittee is authorized to discharge water contaminants subject to the following conditions:

OPERATIONAL PLAN

#	Terms and Conditions
1.	The permittee shall implement the following operational plan to ensure compliance with Title 20, Chapter 6, Parts 1 and 2 NMAC. [20.6.2.3106.C NMAC, 20.6.2.3107 NMAC]
2.	The permittee shall operate in a manner such that standards and requirements of Sections 20.6.2.3101 and 20.6.2.3103 NMAC are not violated. [20.6.2.3101 NMAC, 20.6.2.3103 NMAC]
3.	The permittee is authorized to discharge up to 13,300 gpd of wastewater from the Corrales Elementary School. Wastewater collects in two septic tanks (a 15,000 gallon tank and an 8,000 gallon tank) for solids settling prior to flowing into two lift stations. Wastewater is pumped from the lift stations to a splitter box that distributes it into four synthetically lined constructed wetland cells equipped with aeration. Wastewater then flows through a level adjust manhole into a synthetically lined lagoon for storage followed by a leachfield for disposal. Two standby linear gravel infiltration galleries are available for wastewater disposal in the event of a failure of the other disposal options. [20.6.2.3104 NMAC, 20.6.2.3106 NMAC]
4.	The permittee is not authorized to discharge to the above-ground landscape re-use system that was recently installed and abandoned. In the event that the permittee proposes above ground use of reclaimed wastewater or to use the above ground re-use system, the permittee shall obtain a Discharge Permit Modification from NMED, prior to discharge. [20.6.2.3104 NMAC, 20.6.2.3106 NMAC]
5.	In the event that a connection to the Corrales municipal sanitary sewer system becomes available to this facility, connection to the municipal sanitary sewer shall occur within the shortest period practical and all domestic/commercial wastewater from this facility will be discharged to the municipal sanitary sewer, once connected. Following the connection to a municipal sanitary sewer, the permittee shall perform all closure measures required by this Discharge Permit. [20.6.2.3109 NMAC]
6.	Treated wastewater discharged from the constructed wetland cells shall not exceed the following limitation: Total Nitrogen: 20 mg/L. [20.6.2.3109 NMAC]
7.	The permittee shall maintain fences around the wastewater treatment facility to control public access. The fences shall be constructed in a manner which prevents access by the general public and animals such as dogs (e.g., chain link or field fencing) and shall be maintained throughout the term of this Discharge Permit. [20.6.2.3109 NMAC]
8.	The permittee shall maintain signs at the facility entrance and other areas where public contact is possible indicating that the water is not potable. All signs shall remain visible and legible for the term of this Discharge Permit. [20.6.2.3109 NMAC]

9.	<p>Within 60 days of the effective date of this Discharge Permit (by Month XX, 2010), the permittee shall measure the thickness of the sludge blanket in the lagoon. If sludge accumulation exceeds one-third of the maximum liquid depth of a lagoon at any location within the lagoon, the permittee shall remove the sludge to a depth of less than six inches throughout the lagoon in a manner that is protective of the lagoon liner. Removed sludge shall be contained, transported, and disposed of in accordance with all local, state, and federal (40 CFR Part 503) regulations. A report detailing the sludge depth measurement and disposal of excess accumulated solids (if any disposal occurs) shall be submitted to NMED within 180 days of the effective date of this Discharge Permit (by Month XX, 2010). 10.	<p>The permittee shall remove solids from the septic tanks when they exceed $\frac{1}{4}$ of the liquid depth, based upon quarterly sludge blanket depth determinations. The solids shall be contained, transported, and disposed of in accordance with all local, state, and federal (40 CFR Part 503) regulations. Records of solids disposal shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3109 NMAC]</p>
11.	<p>The constructed wetland cells shall be maintained in such a manner as to avoid conditions which could affect the structural integrity of the cells and/or their liner. Such conditions include, but are not limited to:</p> <ul style="list-style-type: none"> • Erosion damage; • Animal activity/damage; • Evidence of seepage; • Evidence of berm subsidence; and/or • The presence of large pieces or large quantities of debris in the wetlands. <p>The permittee shall visually inspect the wetlands and surrounding berms on a monthly basis to ensure proper maintenance. Vegetation growing within and along the outside perimeter of the wetland cells shall be routinely controlled by mechanical removal in a manner that is protective of the liner. Any evidence of damage to the wetlands berm or liner shall be reported to NMED immediately upon discovery. [20.6.2.3107 NMAC]</p>
12.	<p>The lagoon shall be maintained in such a manner as to avoid conditions which could affect the structural integrity of the lagoon and/or lagoon liner. Such conditions include, but are not limited to:</p> <ul style="list-style-type: none"> • Erosion damage; • Animal activity/damage; • The presence of vegetation, such as; aquatic plants, weeds, woody shrubs or trees growing within five feet of the lagoon edge or within the lagoon itself; • Evidence of seepage; • Evidence of berm subsidence; and/or • The presence of large pieces or large quantities of debris in the lagoon. <p>The permittee shall visually inspect the lagoon and surrounding berms on a monthly basis to ensure proper maintenance. Vegetation growing within or around the lagoon shall be routinely controlled by mechanical removal in a manner that is protective of the lagoon</p>

	liner. Any evidence of damage to the lagoon berm or liner shall be reported to NMED immediately upon discovery. [20.6.2.3107 NMAC]
13.	The permittee shall maintain a minimum of two feet of freeboard between the liquid level in the lagoon and the top elevation of the lagoon liner at all times. [20.6.2.3107 NMAC, 20.6.2.3109 NMAC]
14.	The permittee shall utilize operators, certified by the State of New Mexico at the appropriate level, to operate the wastewater collection, treatment and disposal systems. All operations and maintenance of all or any part of the wastewater system shall be performed by, or under the direct supervision of, a certified operator. [20.7.4 NMAC]

MONITORING, REPORTING, AND OTHER REQUIREMENTS

15.	The permittee shall conduct the following monitoring, reporting, and other requirements listed below. [20.6.2.3107 NMAC]
16.	<p>METHODOLOGY - Unless otherwise approved in writing by NMED, the permittee shall conduct sampling and analysis in accordance with the most recent edition of the following documents:</p> <ul style="list-style-type: none"> a) American Public Health Association, Standard Methods for the Examination of Water and Wastewater (18th, 19th or current); b) U.S. Environmental Protection Agency, Methods for Chemical Analysis of Water and Waste; c) U.S. Geological Survey, Techniques for Water Resources Investigations of the U.S. Geological Survey; d) American Society for Testing and Materials, Annual Book of ASTM Standards, Part 31.Water; e) U.S. Geological Survey, et al., National Handbook of Recommended Methods for Water Data Acquisition; or f) Methods of Soil Analysis: Part 1. Physical and Mineralogical Methods and Part 2. Chemical and Microbiological Properties, American Society of Agronomy. <p>[20.6.2.3107.B NMAC]</p>
17.	<p>The permittee shall submit quarterly monitoring reports to NMED for the most recently completed quarterly period by the 1st of February, May, August and November each year.</p> <p>Quarterly monitoring shall be performed during the following periods:</p> <ul style="list-style-type: none"> • January 1st through March 31st (first quarter) – due by May 1st; • April 1st through June 30th (second quarter) – due by August 1st; • July 1st through September 30th (third quarter) – due by November 1st; and • October 1st through December 31st (fourth quarter) – due by February 1st.

	Monitoring requirements detailed in this Discharge Permit are summarized on the sheet titled <i>Summary of Required Actions, Monitoring and Reporting</i> . [20.6.2.3107 NMAC]
18.	The permittee shall estimate the volume of wastewater discharged monthly to the wastewater treatment system by recording the monthly meter readings for the facility's water supply and calculating the monthly water usage. The permittee shall make note of any significant uses of the water during each month, such as irrigation or evaporative cooling, that do not contribute to the wastewater treatment system. The monthly meter readings, calculated water usage, notes and estimated volume of wastewater discharged shall be submitted to NMED in the quarterly monitoring reports. The water supply meter shall be kept operational at all times. [20.6.2.3107.A(1) NMAC, 20.6.2.3109.H(1) NMAC]
19.	Within 120 days of the effective date of this Discharge Permit (by Month XX, 2010), the permittee shall survey all wells approved by NMED for Discharge Permit monitoring purposes to a U.S. Geological Survey (USGS) or other permanent benchmark. Survey data shall include northing, easting and elevation to the nearest hundredth of a foot or in accordance with the "Minimum Standards for Surveying in New Mexico" (12.8.2 NMAC). A survey elevation shall be established at the top-of-casing, with a permanent marking indicating the point of survey. The survey shall be completed and certified by a licensed New Mexico professional surveyor. Depth-to-water shall be measured to the nearest hundredth of a foot in all surveyed wells, and the data shall be used to develop a map showing the location of all monitoring wells and the direction and gradient of ground water flow at the facility. The data and map of ground water flow direction at the facility shall be submitted to NMED within 30 days of survey completion. [20.6.2.3107 NMAC]
20.	<p>The permittee shall perform quarterly ground water sampling in seven monitoring wells and analyze the samples for NO₃-N, TKN, Cl, iron, manganese and TDS. The permittee shall sample:</p> <ul style="list-style-type: none"> • MW-1 (SWMW-1), located southwest of the constructed wetland cells; • MW-2 (WMW-2), located west of the constructed wetland cells (currently damaged); • MW-3 (NWMW-3), located northwest of the facility; • MW-4 (NMW-4), located north of the leachfield; • MW-5 (NEMW-5), located east of the synthetically lined lagoon; • MW-6 (EMW-6), located east of the constructed wetland cells and • MW-7 (SEMW-7), located southeast of the constructed wetland cells. <p>Ground water sample collection, preservation, transport and analysis shall be performed according to the following procedure:</p> <ol style="list-style-type: none"> a) measure the depth-to-ground water from the top of well casing to the nearest hundredth of a foot; b) purge three well volumes of water from the well prior to sample collection; c) obtain samples from the well for analysis; d) properly prepare, preserve and transport samples; and e) analyze samples in accordance with the methods authorized in this Discharge Permit.

	Depth-to-water measurements, analytical results, including the laboratory QA/QC summary report, and a facility layout map showing the location and number of each well shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]
21.	The permittee shall develop a ground water elevation contour map on a quarterly basis using the monitoring well survey data and quarterly depth-to-water measurements required by this Discharge Permit. The ground water elevation contour map shall depict the ground water flow direction based on the ground water elevation contours. The data and ground water elevation contour maps shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]
22.	Within one year of the effective date of this Discharge Permit (by Month XX, 2010), the permittee shall, propose to either replace or abandon the existing damaged monitoring well, MW-2. In the event ground water flow data indicates the monitoring well is located downgradient of the wetland cells, the permittee shall replace MW-2 with a new monitoring well (MW-2A). The new monitoring well shall be installed within 50 feet west of the constructed wetland cells, within 15 months of the effective date of this Discharge Permit (by Month XX, 2011). However should ground water flow data indicate MW-2 is not effectively monitoring ground water quality downgradient of the wetland cells, the permittee shall propose to abandon MW-2. The replacement monitoring well location shall be approved by NMED prior to installation. The well shall be completed or abandoned in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i> , Revision 1.0, July 2008. Construction and lithologic logs shall be submitted to NMED within 30 days of replacement well completion. [20.6.2.3107 NMAC]
23.	The permittee shall sample wastewater from the level-adjust manhole on a quarterly basis and analyze the samples for TKN, NO ₃ -N, TDS and Cl. Analytical results shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]
24.	The permittee shall inspect the grease interceptor on a quarterly basis and pump it as needed. Inspection records shall be kept on-site. Pumping invoices shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3109 NMAC]
25.	The permittee shall inspect the lift stations on a quarterly basis, and clean as needed. The inspection and cleaning records shall be submitted to NMED in the quarterly monitoring reports. [20.6.2.3107 NMAC]
26.	The permittee shall visually inspect the area above the leachfield quarterly to ensure proper maintenance. Any conditions that indicate damage to the leachfield shall be corrected. Such conditions include, but are not limited to erosion damage, animal activity/damage, woody shrubs or evidence of seepage. The permittee shall keep a log of the inspection findings and repairs made. [20.6.2.3107 NMAC]

CONTINGENCY PLAN

#	Terms and Conditions
27.	<p>In the event that monitoring indicates ground water standards are violated during the term of this Discharge Permit, upon closure of the facility or during post-closure monitoring, the permittee shall collect a confirmatory sample from the monitoring well within 15 days to confirm the initial sampling results. Within 15 days of confirmation of ground water contamination, the permittee shall submit to NMED a corrective action plan that proposes measures to mitigate damage from the discharge including, at a minimum, source control measures and an implementation schedule. The permittee may be required to abate water pollution pursuant to Sections 20.6.2.4000 through 20.6.2.4115 NMAC, if the corrective action plan will not result in compliance with the standards and requirements set forth in Section 20.6.2.4103 NMAC within 180 days of confirmation of ground water contamination. [20.6.2.1203 NMAC, 20.6.2.4105.A(8) NMAC]</p>
28.	<p>In the event of a spill or release that is not authorized under this Discharge Permit, the permittee shall initiate the notifications and corrective actions as required in Section 20.6.2.1203 NMAC. The permittee shall take immediate corrective action to contain and remove or mitigate the damage caused by the discharge. Within 24 hours after discovery of the discharge, the permittee shall verbally notify NMED and provide the information required by Paragraph (1) of Subsection A of 20.6.2.1203 NMAC. Within seven days of discovering the discharge, the permittee shall submit a written report to NMED verifying the oral notification and providing any additional information or changes. The permittee shall submit a corrective action report within 15 days after discovery of the discharge. [20.6.2.1203 NMAC]</p>
29.	<p>In the event NMED or the permittee identifies any other failures of the Discharge Permit or system not specifically noted herein, NMED may require the permittee to develop for NMED approval contingency plans and schedules to cope with the failures. [20.6.2.3107.A(10) NMAC]</p>
30.	<p>In the event that analytical results of a quarterly treated wastewater sample exceed the total nitrogen limitation set in this Discharge Permit, the permittee shall analyze another sample within 15 days to confirm the initial results. Upon confirmation that the limitation is being exceeded, the permittee shall enact the following contingency plan:</p> <ol style="list-style-type: none"> a) NMED shall be notified immediately that the contingency plan is being enacted. b) Wastewater sampling and analysis shall be done on a monthly basis. c) The permittee shall examine the operation and maintenance log, required under the Record Keeping section of this permit, for improper operational procedures. The permittee shall also conduct a physical inspection of the treatment system to detect abnormalities. Any abnormalities discovered shall be corrected. d) If analytical results from wastewater sampling continue to exceed the limitation, the permittee shall submit a corrective action plan for NMED approval to modify operational procedures and/or upgrade the treatment process to achieve the effluent limit. The plan shall be submitted within 90 days of the original confirmation of

31.	<p>In the event that ground water flow information obtained pursuant to this Discharge Permit indicates that a monitoring well(s) was not installed hydrologically downgradient of the intended discharge location(s), the permittee shall install a replacement well(s) within 90 days of notification from NMED. The well location(s) shall be approved by NMED prior to installation and completed in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008. Construction and lithologic logs shall be submitted to NMED within 30 days of well completion. [20.6.2.3107 NMAC]</p>
32.	<p>In the event that a minimum of two feet of freeboard cannot be maintained in the lagoon at all times, the permittee shall submit a corrective action plan for NMED approval within 30 days of the date when the two feet of freeboard limit was initially exceeded.</p> <p>[20.6.2.3107 NMAC, 20.6.2.3109 NMAC]</p>
33.	<p>In the event that inspection findings reveal significant damage likely to affect the ability of the lined lagoon to contain contaminants, the permittee shall submit a corrective action plan for the repair or replacement of the lagoon liner to NMED for approval within 30 days of discovery by the permittee or following notification from NMED that significant liner damage is evident. [20.6.2.3107 NMAC, 20.6.2.3109 NMAC]</p>
34.	<p>In the event that inspection findings reveal significant damage likely to affect the ability of the synthetically lined constructed wetland cells to contain contaminants, the permittee shall submit a corrective action plan for the repair or replacement of the constructed wetland liners to NMED for approval within 30 days of discovery by the permittee or following notification from NMED that significant liner damage is evident.</p> <p>[20.6.2.3107 NMAC, 20.6.2.3109 NMAC]</p>
35.	<p>In the event that an inspection of the leachfield reveals failure, the permittee shall enact the following contingency plan:</p> <ol style="list-style-type: none"> a) Within 24 hours of the discovered failure, the permittee shall notify NMED of the failure and public access to the area shall be restricted. b) The permittee shall conduct a physical inspection of the treatment and disposal system to identify additional failures. c) The permittee shall submit a corrective action plan for NMED approval to address the failure and propose methods of correction. 36.	<p>Upon closure of the facility, the permittee shall perform the following closure measures:</p> <ul style="list-style-type: none"> a) Remove or plug all lines leading to the treatment system, lagoon and disposal area so that a discharge can no longer occur. b) Drain and/or evaporate all liquids from the lift stations, septic tanks, constructed wetlands cells and lagoon and dispose of all sludge in accordance with all local, state, and federal (40 CFR Part 503) regulations. c) Backfill the lift stations and septic tanks with clean fill or sand or remove or demolish all tanks and re-grade the area with clean fill to blend with surface topography and prevent ponding. d) Perforate or remove the constructed wetland cells and lagoon liners and re-grade the wetland and lagoon areas with clean fill to blend with surface topography and prevent ponding. e) Continue ground water monitoring as required by this Discharge Permit for two years after closure to confirm the absence of ground water contamination. If monitoring results show that the ground water standards in Section 20.6.2.3103 NMAC are being violated, the permittee shall implement the contingency plan required by this Discharge Permit. f) Following notification from NMED that post-closure monitoring may cease, the permittee shall plug and abandon the monitoring wells in accordance with the attachment titled <i>Ground Water Discharge Permit Monitoring Well Construction and Abandonment Conditions</i>, Revision 1.0, July 2008. <p>When all post-closure requirements have been met, the permittee may request to terminate the Discharge Permit. 37.	<p>RECORD KEEPING - The permittee shall maintain at the facility a written record of all data and information related to field measurements, sampling, and analysis conducted pursuant to this Discharge Permit. The following information shall be recorded and shall be made available to NMED upon request:</p> <ul style="list-style-type: none"> a) The dates, exact place and times of sampling or field measurements; b) The name and job title of the individuals who performed each sample collection or field measurement; c) The date of the analysis of each sample; d) The name and address of the laboratory and the name and job title of the person that performed the analysis of each sample; e) The analytical technique or method used to analyze each sample or take each field measurement; f) The results of each analysis or field measurement, including raw data;

	<p>g) The results of any split sampling, spikes or repeat sampling; and h) A description of the quality assurance and quality control procedures used. [20.6.2.3107.A NMAC]</p>
