The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE), Newport News Nuclear BWXT-Los Alamos, LLC (N3B), and Triad National Security, LLC (Triad) (Collectively, the Respondents) *Site Treatment Plan, Fiscal Year 2023 Annual Update and Proposed Revision 34.0, Federal Facility Compliance Order, October 4, 1995* (STP Annual Update), dated and received March 19, 2024, and referenced by EM2024-0020/N3B-2024-0006.

On May 16, 2024, NMED issued a public notice of Intent to Approve the Annual Update. The 30-day public comment period ended on June 15, 2024. NMED has received no comments on the proposed revision, and NMED is approving the STP Annual Update.
