

The New Mexico Environment Department (NMED) is in receipt of the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (collectively, the Permittees) document entitled *Chromium Extraction Well Evaluation Report and Recommendations for CrEX-2* (Report) dated May, 2017 and referenced by EP2017-0065. The Report was received on April 25, 2017.

In accordance with Section XXIII of the 2016 *Compliance Order on Consent* (Consent Order), a pre-submission meeting was held on March 16, 2017, where NMED and the Permittees resolved all pertinent issues concerning the Report. Specifically, NMED emphasized requirements regarding the technical content of the Report such as plume response to pumping at extraction wells CrEX-1 and CrEX-3. NMED has reviewed the Permittees' Report and hereby issues this Approval.


