I. Proposed Draft Supplemental Regulations for Ground and Surface Water Reuse Regulations Public Involvement Plan Overview

The New Mexico Environment Department (Department or NMED) developed this Public Involvement Plan (PIP) for rulemaking activities related to NMED's proposed supplemental regulations for water reuse for ground and surface water protection. These regulations are being developed as partial fulfillment of the state's Produced Water Act (PWA) (NMSA 1978, 70-13) and the Water Quality Act (WQA) (NMSA 1978, 74-6-4), which require the Water Quality Control Commission (WQCC) to adopt regulations to be administered by the Department for protection of human health and the environment and "...for the discharge, handling, transport, storage, recycling or treatment for the disposition of treated produced water..."

This PIP outlines the Department's plan for providing the public with opportunities to participate in the reuse regulation rulemaking process. The PIP also identifies Department staff and resources needed to accomplish these activities. This PIP integrates information about the community and identifies resources needed by the Department to successfully incorporate community participation activities into the decision-making process. The Department will meet public participation requirements for the reuse regulation rulemaking process by following this PIP, which includes all applicable policy, regulatory, and statutory public participation requirements.

In developing this PIP, NMED assessed community participation needs to ensure appropriate promotion of public outreach by identifying whether there is a combination of environmental and demographic factors (i.e., low income community, minority community, limited English proficiency individuals, Linguistically Isolated Households, etc.) that may impact public participation.¹ This assessment identifies community outreach needs and provides for public access opportunities and adequate public access to information regarding this activity.

The proposed reuse regulations have state-wide impact to a relatively large community of Spanish speakers. Therefore, based on the information in the Demographic Summary of this PIP (see Section IV), the Department will provide pertinent information in both English and Spanish in public meeting notices, public comment notices, and other announcements (radio broadcasts, brochures, signs, postcards, fact sheets, etc.), as necessary. The proposed reuse regulations are applicable state-wide. As such, the Department will provide public meeting notices, public comment notices, and other pertinent information in English, and Spanish. Other language translation will be provided, as the Department can reasonably accommodate, in coordination with the Department's Tribal Liaison and/or Non-Discrimination Coordinator, and upon request, allowing two weeks advance notice. During public comment periods, relevant documents may be reviewed on the Department's website, provided upon request by email/hard copy, or reviewed during normal business hours in hard copy at the Harold Runnels Building, 1190 St. Francis Dr., Santa Fe.

This PIP is a "living" document that may be amended after considering public comments and feedback. The Division Director and NMED General Counsel provide final approval of the PIP and revisions.

III. Background for Public Participation

The Department involves the public and other stakeholders in the development of surface water quality standards, codified in 20.6.4 NMAC, and ground and surface water protection regulations, codified in 20.6.2 NMAC. The Department will provide opportunity for public participation as required in the State's approved Water Quality management Plan and Continuing Planning Process (WQMP/CPP) and applicable WQCC Rulemaking Procedures (20.1.6 NMAC).

A Public Involvement Plan (PIP) for the Implementation of House Bill 546, the Produced Water Act, was approved and made available to the public in October 2019. The Department is proposing a supplemental Ground and Surface Water Protection water reuse regulation, which, in part, includes the restricted use of Produced Water. Given the scope of this reuse regulation, the public engagement needs have been reviewed and updated as part of this PIP.

IV. Location and Demographics

Water reuse planning and implementation activities have statewide effects, and thus this document will address public engagement and outreach related to regulation development for the entire state as outlined below.

Demographic Summary

Using the US Census Bureau, 2016-2020 American Community Survey (ACS) report, New Mexico has an estimated population of 2,097,021; 49 percent identify as Hispanic; 9 percent identify exclusively as American Indian, with 63% of the total population being "minority²." In addition, an estimated 169,269 individuals (9%) over the age of 5 speak English "less than very well." Of the 40,736 linguistically isolated households³ in New Mexico, 81% speak Spanish, 2% speak other Indo-European languages, 4% speak Asian-Pacific languages, and 13% speak other or non-specified languages. The per capita income for New Mexico is \$27,945 as compared to the national per capita income of \$37,638, with 18.4% of New Mexico's population living in poverty.

These results indicate that for the state of New Mexico, the percentage of non-English speaking

communication is considerable (i.e., substantially greater than the national percentage) and there are demographic factors (i.e., low-income community, minority community, limited English proficiency individuals, Linguistically Isolated Households, etc.) that may impact public participation.

It is important for the Department to incorporate the linguistic and communication needs of communities in the State when conducting public outreach and participation activities for statewide issues. Therefore, based on the analysis summarized in the previous paragraphs, the Department will provide information in Spanish and in English for public comment notices, public meeting notices, public hearing notices, and other announcements (radio broadcasts, brochures, signs, postcards, etc.) as needed, and strive to make public participation efforts as inclusive as possible within Department's budget and time limitations. Specific repository addresses that may be used, depending on need, are provided in this PIP in Section VI, below.

V. Public Participation and Outreach Activities

The Department will conduct the following outreach activities:

- Providing the public with the information and assistance necessary for meaningful involvement;
- Providing a central location of reports, studies, plans, and other documents;
- Maintaining a list of affected or interested parties and stakeholders;
- Notifying stakeholders in a timely fashion prior to consideration of major decisions (generally at least 30 days);
- Providing, at a minimum, a 30-day public comment period for proposed draft language;
- Petitioning the WQCC at a public meeting to request a public rulemaking hearing;
- Publishing the public hearing notice in the New Mexico Register, in two newspapers of general circulation, and mailed (or emailed) to the stakeholder list at least 60 days prior to the hearing date;
- Posting rulemaking information on NMED's website;
- Posting rulemaking information on State's Sunshine Portal;
- Providing email notification of the public hearing with links to supporting documentation to NMED's district managers to make available at NMED field offices;
- Providing email notification of the public hearing with links to supporting documentation to the Small Business Administration;
- Providing email notification (if provided) of the public hearing with links to supporting documentation to persons who have identified as a stakeholder, participated in the rulemaking, or specifically made a request for notice;
- Sending written notice that includes at a minimum, an internet and street address where the information may be found to persons who provide a postal address;
- Providing notice of hearing to the New Mexico legislative council for distribution to appropriate legislative committees;
- Holding a public hearing before the WQCC;
- Publishing the approved regulation in the New Mexico Register with the effective date of the regulations; and
- Posting WQCC approved regulations on NMED's website.

A. Postal Mailing or Emailing of Notices to Persons on the Stakeholder List

The Department is maintaining a stakeholder list for this rulemaking action that includes individuals that have self-identified as directly impacted by, have a legal obligation to, or have some other particularized

interest in reclaimed water reuse regulations. This list was created in September 2023 as a combination of all previously interested persons who requested the Department provide them with information about regulatory development of water reuse regulations. The Department regularly maintains contact information, which is updated or supplemented if additional information is found. The list also includes pre-identified local, state, and federal governments. Interested persons that have provided both an address and email may receive physical mail and an email. Additional individuals, organizations, and other stakeholders are added to the mailing list as requested.

B. E-Mail Updates

The Department maintains several email listservs through GovDelivery that include individuals interested in water quality issues and activities. This list contains email addresses for all persons who requested the Department provide them with information about water quality issues via these listservs. The Department adds additional individuals, organizations, and other interested parties to the list as requested. F. Public Comment Period

The 30-day public comment period for the proposed draft Ground and Surface Water Reuse Regulations, required in accordance with the State's approved Water Quality Management Plan and Continuing Planning Process is tentatively scheduled for the Fall of 2023.

G. Water Reuse Regulation Rulemaking, Outcomes, and Responses to Comments

To address stakeholder and community members who submitted formal comments on the proposed reuse rules, the Department will prepare the final draft regulation as amended, including a Response to Comments document, following the close of the public comment period. The WQCC's rulemaking regulations (20.1.6 NMAC) require the Department petition the WQCC for a public rulemaking hearing. NMED's proposed draft regulations and supporting documentation will be available to the public on the WQCC's website at https://www.env.nm.gov/opf/docketed-matters/. Upon approval and adoption by the WQCC, the rule will be published, with an effective date in the New Mexico Register.

H. PIP Contingency Plan

During a public health emergency or other unforeseen event outside the control of the Department, the Department will make every effort to ensure the public remains involved in and informed of the decision making and rule development processes. The purpose of this PIP Contingency Plan is in part to address circumstances when public spaces are closed because of potential human exposure risks. The Department will attempt to identify and utilize alternate methods of document delivery to the public and public viewing when conventional methods and locations are unavailable. When it is unsafe to utilize the physical PIP and document repositories, the Department will consider utilizing electronic delivery methods deemed appropriate for the permitting action. During the times of potential human exposure risks and the resultant implementation of this PIP Contingency Plan, the Department will only hold public meetings when or through means by which the Department can ensure the public's health and safety and this PIP can be fully adhered to.
