FINAL ORDER

This matter comes before the Secretary of Environment following a hearing before a Hearing Officer on May 19 and 20, 2025, in Santa Fe, New Mexico.

BL Santa Fe, LLC ("Applicant" or "Bishop's Lodge") seeks an eighth renewal and the modification of its groundwater discharge permit for the planned discharge of up to 30,000 gallons per day (gpd) of domestic wastewater. Applicant proposes to upgrade its treatment system to a membrane bioreactor (MBR) package plant, and to discharge Class 1A reclaimed domestic wastewater to an irrigation system. Applicant also proposes discharge to a subsurface, low-pressure dosed dispersal field and that the associated sludge be discharged to a synthetically lined reed bed for treatment and stabilization prior to disposal offsite. The property, a resort, is located approximately three miles north of Santa Fe, New Mexico, within the Tesuque Formation.

The Ground Water Bureau (Bureau) supports the issuance of the permit with conditions necessary to protect public health and welfare and the environment.

Having considered the administrative record in its entirety, including all post-hearing submittals and the Hearing Officer's Report; and being otherwise fully advised regarding this matter;

THE SECRETARY HEREBY ADOPTS THE HEARING OFFICER'S REPORT AND PROPOSED

FINDINGS OF FACT AND CONCLUSIONS OF LAW, except as follows: the Bureau submitted and the

Hearing Officer recommended the issuance of the August 8, 2025 Second Revised Draft Permit.

Subsequently, the Bureau and Applicant submitted comments on the Hearing Officer's

Report, and the Bureau agreed that on August 20, 2025, Applicant sampled the organic and

inorganic constituents that would have been required for sampling in new proposed Conditions 37

and 38; that the analytical sampling results, QA/QC summary, and chain of custody information were

provided to the Bureau; and that all organic and inorganic constituents enumerated were either

non-detect or well under the groundwater standards set out in 20.6.2.3103 NMAC. The

administrative and evidentiary record provide no basis for ongoing testing of Section 3103

constituents not ordinarily found in domestic wastewater, and Conditions 37 and 38 are no longer

apt in response to oral and written public comment.

IT IS THEREFORE ORDERED:

1. The application for the discharge permit is granted.

2. The permit shall be issued by the Ground Water Bureau in the form set forth in Draft

Permit DP-75 without Conditions 37 and 38.
