## <u>Air Quality Operating Permit</u> for Portales Plant of Portales Dairy Products, LLC

Portales Dairy Products, LLC at 1820 S Industrial Dr; Portales, NM 88130 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Portales Plant. The owner of this plant is Portales Dairy Products, LLC. The exact location of the facility is at latitude and longitude decimal degrees: 34.16005, -103.379636 Datum: WGS84. To aid in locating this facility, the approximate location is 0.6 mi SW of Portales in Roosevelt County, NM. This application file has been assigned an Operating Permit Number P234-R3 and TEMPO Agency Interest ID No. 1094.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to produce cream, condensed milk, milk powder, and milk protein from whole raw milk. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action incorporates the changes already permitted in construction permit NSR 1263-M6, including removal of one dryer and scrubber, increasing capacity of two heaters, and reducing the size of a dust collector.

The emissions, as established in NSR Permit 1263-M6 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P234-R2-M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 109.6 tpy (-8.4); Carbon Monoxide (CO) at 93.8 tpy (-34.7); Volatile Organic Compounds (VOC) at 4.7 tpy (-0.3); Sulfur Dioxide (SO<sub>2</sub>) at 12.4 tpy (-0.7); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 8.0 tpy (-1.5); Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 8.0 tpy (-1.5); and greenhouse gas (CO<sub>2</sub>e) >75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A and Dc; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before August 25, 2022.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P234-R3 by contacting Vanessa Springer at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at Vanessa.Springer@state.nm.us.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
