<u>Air Quality Operating Permit</u> for South Carlsbad Compressor Station of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its South Carlsbad Compressor Station. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 32.315428, -104.136542 Datum: WGS84. To aid in locating this facility, the approximate location is 2.8 miles NW of Loving in Eddy County, NM. This application file has been assigned an Operating Permit Number P130R4 and TEMPO Agency Interest ID No. 218.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress natural gas for transportation to pipeline.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action incorporates the changes reflected in NSR 0220M11 consisting of the addition of a turbine (Unit 5) controlled with a SoloNOx unit, removal of the dew point plant, amine system and amine flare, update to the slop, condensate, and loadout tank emissions and throughputs, and SSM/M revisions to flaring emissions.

The emissions, as established in NSR Permit 0220M11 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P130R3M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 211.3 tpy (-26.5); Carbon Monoxide (CO) at 82.7 tpy (-86.7); Volatile Organic Compounds (VOC) at 142.3 tpy (-32.7); Sulfur Dioxide (SO₂) at 17.0 tpy (-16.8); Particulate Matter 10 microns or less (PM₁₀) at 6.7 tpy (-0.5), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 6.7 tpy (-0.4); and greenhouse gas (CO₂e) > 75,000 tpy.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, GG, and OOOOa; 40 CFR 63 Subparts A and HH; 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before June 15, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P130R4 by contacting Julia Kuhn at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at julia.kuhn@state.nm.us. Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public. The permit application is currently available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/public-notices.
