Air Quality Operating Permit for Chaparral Gas Plant of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 772104324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Chaparral Gas Plant. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is at latitude and longitude decimal degrees: 32.654183, -103.894872 Datum: WGS84. To aid in locating this facility, the approximate location is 12 miles SW of Loco Hills in Eddy County, NM. This application file has been assigned an Operating Permit Number P264-R1M1 and TEMPO Agency Interest ID No. 26896.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to process natural gas for the removal of water, crude oil condensates, and carbon dioxide, and through fractionation extracts natural gas liquids (NGL) using cryogenic distillation. A parallel mechanical refrigeration process removes additional hydrocarbon liquids.

This operating permit application is for a permit modification. Per 20.2.70.401.C.(4) NMAC, this permitting action specifically involves correcting an applicability determination by removing NSPS OOOOa and OOOO federal rule applicability for units C-7000 and C-VRU-1, respectively. This action will also add 20.2.50 NMAC applicable requirements.

There are no changes to the existing air emission limits in this permitting action (limits as in TV P264-R1 were carried forward into this action).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 38, 50, 61, 70, 71, 72, 73, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts JJJJ, KKK, OOOO; 40 CFR 63 Subparts HH, ZZZZ, CCCCC; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before April 18, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P264-R1M1 by contacting McKenna Hedgepeth at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at mckenna.hedgepeth@env.nm.gov.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
