Legal Notice For <u>Air Quality Operating Permit</u> for Washington Ranch Storage Facility of El Paso Natural Gas Company, LLC

El Paso Natural Gas Company, LLC at 1001 Louisiana Suite 1000; Houston, TX 77002 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Washington Ranch Storage Facility. The owner of this plant is El Paso Natural Gas Company, LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 32.082869, -104.486331 Datum: WGS84. To aid in locating this facility, the approximate location is 9.1 miles SW of Whites City in Eddy County, NM. This application file has been assigned an Operating Permit Number P064-R4-M2 and TEMPO Agency Interest ID No. 220.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress and inject natural gas into underground storage wells and to withdraw the gas for delivery into the pipeline.

This operating permit application is for a minor permit modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves a Title V minor modification to incorporate the changes to the glycol dehydrator flash tank emissions which consisted of recycling flash tank vapors from the glycol dehydrator to be used as fuel. Hence, this TV minor modification is incorporating NSR 428-M7R6 where those changes were implemented.

The emissions, as established in NSR Permit 0428-M7-R6 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P064-R4. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 243.6 tpy (-4.3); Carbon Monoxide (CO) at 243.4 tpy (-0.8); Volatile Organic Compounds (VOC) at 186.1 tpy (-21.7); Sulfur Dioxide (SO₂) at 4.8 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 10.2 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 10.2 tpy (no change); and greenhouse gas (CO₂e) 37,286 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 50, 61, 70, 71, 72, 73, and 82; 40 CFR 50; 40 CFR 63 Subparts A, HHH, ZZZZ, and DDDDD; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before April 20, 2023.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
