ETC Texas Pipeline LTD at 8111 Westchester Drive Suite 600; Dallas, TX 75225 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Jal No3 Gas Plant. The owner of this plant is ETC Texas Pipeline LTD. The exact location of the facility is at latitude and longitude decimal degrees: 32.173611, -103.174167 Datum: WGS84. To aid in locating this facility, the approximate location is 4 mi NNE of Jal in Lea County, NM. This application file has been assigned an Operating Permit Number P090R3M1 and TEMPO Agency Interest ID No. 569.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the plant is a natural gas treating and processing plant.

This operating permit application is for a permit minor modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves updating the Compliance Assurance Monitoring (CAM) Plan.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this plant will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 33, 35, 37, 61, 70, 71, 72, 73, 74, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, Db, Dc, GG, KKK, LLL, JJJJ, and OOOO; 40 CFR 63 Subparts A, HH, ZZZZ, and DDDDD; 40 CFR 64; 40 CFR 68; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before May 28, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P090R3M1 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at joseph.kimbrell@env.nm.gov.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
