Air Quality Operating Permit for Clovis Regional Solid Waste Facility Landfill of Clovis (City of) Public Works

Clovis (City of) Public Works at PO Box 760; Clovis, NM 88101 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Clovis Regional Solid Waste Facility Landfill. The owner of this plant is Clovis (City of) Public Works. The exact location of the facility is at latitude and longitude decimal degrees: 34.3829, -103.170053 Datum: NAD83. To aid in locating this facility, the approximate location is 2.5 miles southeast of Clovis in Curry County, NM. This application file has been assigned an Operating Permit Number P199LR4 and TEMPO Agency Interest ID No. 111.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to landfill Municipal Solid Waste (MSW) from the City of Clovis and Curry County. It also accepts commercial waste.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewing the current Title V operating permit and increase emitting emissions.

The estimated maximum air pollutant emissions to the atmosphere, from this facility after the requested operating permit is issued, are as follows: Volatile Organic Compounds (VOC) at 7.2 tpy; Hydrogen Sulfide (H_2S) at 0.6 tpy; Total Suspended Particulates (TSP) at 46.4 tpy (+28.7 tpy); Particulate Matter 10 microns or less (PM10) at 13.2 tpy (+10.2); Particulate Matter 2.5 microns or less (PM2.5) at 2.1 tpy (+1.3 tpy); nonmethane organic compounds (NMOC) at 7.1 tpy (-2.8); The facility has minor source stack emission rates of green house gas emissions (< 100,000 tpy CO2e).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 70, 71, 73, and 77; 40 CFR 50; 40 CFR 60 Subparts A; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before July 29, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P199L-R4 by contacting Miranda Baldwin at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at Miranda.baldwin1@env.nm.gov.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public. The permit application is currently available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/public-notices.
