<u>Air Quality Operating Permit</u> for Huerfano Pump Station of Mid-America Pipeline Company LLC

Mid-America Pipeline Company LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Huerfano Pump Station. The owner of this plant is Mid-America Pipeline Company LLC The exact location of the facility is at latitude and longitude decimal degrees: 36.471292, -107.907975 Datum: NAD27. To aid in locating this facility, the approximate location is 17 miles south of Bloomfield in San Juan County, NM. This application file has been assigned an Operating Permit Number P201R4 and TEMPO Agency Interest ID No. 1201.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to boost pipeline internal pressure for transport of natural gas liquids through underground pipelines using natural gas fired turbines.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporates NSR Administrative Permit Revision 0888-M6R3 dated January 23, 2018 and NSR Administrative Permit Revision 0888-M6R4 dated March 26, 2019.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 50, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ, & KKKK; 40 CFR 63 Subparts A & ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before November 5, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P201R4 by contacting Miranda Baldwin at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at miranda.baldwin1@env.nm.gov.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
