Air Quality Operating Permit
for Manzanares Offload Station (Formerly known as Manzanares Compressor Station)
of Enterprise Products Operating LLC

Enterprise Products Operating LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Manzanares Offload Station (Formerly known as Manzanares Compressor Station). The owner of this plant is Enterprise Products Operating LLC. The exact location of the facility is at latitude and longitude decimal degrees: 36.747778, -107.675556 Datum: NAD27. To aid in locating this facility, the approximate location is 5 miles South of Navajo Dam in San Juan County, NM. This application file has been assigned an Operating Permit Number P272R1 and TEMPO Agency Interest ID No. 36504.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to collect and transport natural gas through pipelines.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action does not request any changes to the process or equipment, and emissions will remain as currently permitted. Briefly, the facility processes conventional gas. The Manzanares Offload Station is permitted for operation of two Superior 16SG reciprocating internal combustion engines (RICE), a condensate storage tank, and an instrument gas dryer. The facility can operate continuously, 24 hours per day, seven days per week, 52 weeks per year, and 8,760 hours per year.

The emissions, as established in NSR Permit PSD6703R2 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P272. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 71.3 tpy (no change); Carbon Monoxide (CO) at 119.8 tpy (no change); Volatile Organic Compounds (VOC) at 67.4 tpy (no change); Sulfur Dioxide (SO₂) at 2.3 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 1.5 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 1.5 tpy (no change); and greenhouse gas (CO₂e) < 75,000 tpy.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 50, 61, 70, 71, 72, 73, and 82; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before October 7, 2023.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.

Due to the public health emergency order, certain NMED offices are closed to the public.
