Preliminary Determination for an Air Quality Permit for Cotton Draw Midstream LLC

Cotton Draw Midstream LLC at 333 West Sheridan Ave, Oklahoma City, OK has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to construct Songbird Compressor Station. The application file has been assigned Permit No. 9938 and TEMPO Agency Interest No. 41026. The exact location of the facility is/will be at latitude and longitude decimal degrees: 32.10706, -103.71319, Datum: WGS 84. To aid in locating this facility, the approximate location is 25.6 miles SE of Loving in Lea County, NM.

The proposed construction will consist of a natural gas compressor station that will be gathering 95 MMSCFD of natural gas from various wells in the area. The inlet gas will be compressed by eight (8) natural gas driven compressors engines. After initial separation and compression, condensate and water mixer will be sent to a 750 bbl gunbarrel separator. Gunbarrel will separate condensate and water, and separated liquids (water and condensate) will be stored in the atmospheric storage tanks. Flash, working, and breathing emissions from gunbarrel tank, condensate tanks, and produced water tanks will be controlled by an enclosed combustor device with 98% capture efficiency and 98% destruction removal efficiency. Condensate and produced water loadout will have vapor-balanced tied to the enclosed combustion device. Additionally, a flare will control the maintenance blowdown events with 98% DRE. Compressed gas will be treated using a TEG glycol dehydrator to remove any water content before sending to the pipeline for transport.

Total air pollutant emissions to the atmosphere are estimated to be approximately Nitrogen Oxides (NOx) at 63.2 tons per year (tpy); Carbon Monoxide (CO) at 37.7 tpy; Volatile Organic Compounds (VOC) at 120.6 tpy; Sulfur Dioxide (SO₂) at 30.1 tpy; Particulate Matter 10 microns or less (PM10) at 6.6 tpy; and Particulate Matter 2.5 microns or less (PM2.5) at 6.6 tpy; and greenhouse gas (CO₂e) > 75,000 tpy These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. The preliminary review and applicant's analysis of ambient air quality impacts indicates that the facility's air emissions will meet the air quality standards for Nitrogen Oxides (NO_x), Carbon Monoxide (CO), Sulfur Dioxide (SO_2), Particulate Matter 10 microns or less (PM10), Particulate Matter 2.5 microns or less (PM2.5). VOCs are a pre-cursor to ozone and the NMED does not require an individual ozone ambient impacts indicates and other the application. impact analysis for each application. To determine compliance with national ambient air quality standards for ozone, NMED uses air monitors to monitor ozone concentrations. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice and determine compliance with ambient air quality requirements and standards.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 7, 50, 61, 70, 72, 73, 75, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, OOOOD, and JJJJ; 40 CFR 63 Subparts A, HH, and ZZZZ; 40 CFR 68;and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before July 25, 2023. This source is a PSD minor source according to 20.2.74 NMAC.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions, implement federal NSPS and MACT requirements, monitor engines, compressors, tanks, loading, and combustors, and conditions that will require record keeping and reporting to the Department.

The permit application is available for review on the NMED Public Participation website www.env.nm.gov/public-notices. All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, facility name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The Department will notify all persons, who have provided written comments as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing before the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment before the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
