FINAL ORDER

This matter comes before the Secretary of Environment following a hybrid hearing before the Hearing Officer on September 25, 2023.

Targa Northern Delaware seeks to modify its air quality permit for its Road Runner Facility, a gas processing plant located 1.6 miles south-southwest of Loving, in Eddy County, 4 miles northwest of Malaga.

The New Mexico Environment Department Air Quality Bureau supports the approval of the permit modification with conditions necessary to protect human health and welfare and the environment.

Having considered the administrative record, including the parties' post-hearing submittal and the Hearing Officer's Report; and being otherwise fully advised regarding this matter;

THE SECRETARY HEREBY ADOPTS THE HEARING OFFICER'S REPORT AND RECOMMENDED FINDINGS OF FACT AND CONCLUSIONS OF LAW.

IT IS THEREFORE ORDERED:

1. The application for an air quality construction permit modification is granted, and the permit modification shall be issued by the Air Quality Bureau in the

- form set forth on August 30, 2023, at AR Bates No. 20566-20600 (Part A) and 1710-1731 (Parts B and C).
- 2. Under 20.1.4.500.C(2), unless otherwise ordered by the Secretary, a party may file comments on the Hearing Officer's Report within 15 days. Because the Hearing Officer adopted the parties' proposed findings and conclusions, no comments will be accepted, and the Secretary will issue a final order within the next 30 days.
