and
Preliminary Determination for an Air Quality Permit for
Schlumberger Technology Corp - Artesia

Schlumberger Technology Corp - Artesia at PO Box 300, Artesia, NM has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to modify Artesia District Bulk Facility. The application file has been assigned Permit No. 0058M4 and TEMPO Agency Interest No. 3403. The exact location of the facility is at latitude and longitude decimal degrees: 32.858056, -104.393333 Datum: WGS84. To aid in locating this facility, the approximate location is 507 E Richey Ave, in Eddy County, NM.

The proposed modification will consist of adding three additional silos (SILO 3A, 4A, 5A), with associated dust collectors, and a pig tank (PIG 2) for storing cement product. Schlumberger also seeks in this application to remove three silos (SILO 14, 15, 16), with associated dust collectors.

Total air pollutant emissions to the atmosphere are estimated to be approximately Particulate Matter 10 microns or less (PM10) at 0.21 tpy; and Particulate Matter 2.5 microns or less (PM2.5) at 0.21 tpy; and greenhouse gas (CO₂e) < 75,000 tpy. These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. The preliminary review and applicant's analysis of ambient air quality impacts indicates that the facility's air emissions will meet the air quality standards for PM10 and PM2.5. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice and determine compliance with ambient air quality requirements and standards.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 3, 7, 72, 73, and 75; 40 CFR 50; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before January 13, 2024. This source is a PSD minor source according to 20.2.74 NMAC.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions, production rate, and conditions that will require record keeping and reporting to the Department.

The permit application is available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/public-notices, under Eddy County.

All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, facility name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The Department will notify all persons who have provided written comments as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing before the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment before the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
