## Legal Notice For <u>Air Quality Operating Permit</u> <u>for Buena Vista Compressor Station of Harvest Four Corners LLC</u>

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Buena Vista Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 36.274750, -107.698944 Datum: WGS84. To aid in locating this facility, the approximate location is 2 miles East-Northeast of Nageezi in San Juan County, NM. This application file has been assigned an Operating Permit Number P275R1 and TEMPO Agency Interest ID No. 35662.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress natural gas for gathering pipeline transmission using natural gas-fired reciprocating engines.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action incorporates the changes reflected in NSR 6362M1 consisting of modifying the option to install and operate three of either Waukesha 7042GL or a Waukesha 5790GL engines, to the option of installing three of either Waukesha 7042GL or Caterpillar 3516 TALE engines.

The emissions, as established in NSR Permit 6362M1 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P275. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 70.6 tpy (+12.1); Carbon Monoxide (CO) at 104.9 tpy (+1.5); Volatile Organic Compounds (VOC) at 237.0 tpy (+2.4); Sulfur Dioxide (SO<sub>2</sub>) at 0.08 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 1.3 tpy (no change), and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 1.3 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) < 75,000 tpy.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 50, 61, 70, 71, 72, 73, 75, 77, and 82; 40 CFR 60 Subparts A and OOOOa; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before February 9, 2024.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
