Legal Notice For <u>Air Quality Operating Permit</u> for Willow Lake Gas Processing Plant of Crestwood New Mexico Pipeline, LLC

Crestwood New Mexico Pipeline, LLC at 811 Main Street Suite 3400; Houston, TX 77002 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Willow Lake Gas Processing Plant. The owner of this plant is Crestwood New Mexico Pipeline, LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 32.194986, -104.103303 Datum: WGS84. To aid in locating this facility, the approximate location is 2.7 mi SW of Malaga in Eddy County, NM. This application file has been assigned an Operating Permit Number P299 and TEMPO Agency Interest ID No. 32575.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress and dehydrate natural gas liquids (NGL) streams coming into the facility.

This operating permit application is for a new permit. Per 20.2.70.401.C.(4) NMAC, this permitting action involves incorporation of changes made in the issued NSR permit 5142-M8. The NSR permit 5142-M8 added three (3) compressor engines, one (1) tank, one (1) TEG glycol dehydrator and one (1) reboiler, updated control efficiency for seven existing engines, revised flare emission calculation to accommodate new equipment, revised tank calculations based on estimated increase in throughput, updated fugitive components, and added a backup vapor recovery unit.

The emissions, as established in NSR Permit 5142-M8 and brought forward into this permit are as follows. This is the first Title V permit for the facility, and there are no previous Title V permits to compare the changes in emissions. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 165.8 tpy; Carbon Monoxide (CO) at 131.3 tpy; Volatile Organic Compounds (VOC) at 148.3 tpy; Sulfur Dioxide (SO₂) at 11.9 tpy; Particulate Matter 10 microns or less (PM₁₀) at 9.6 tpy, and Particulate Matter 2.5 microns or less (PM_{2.5}) at 9.6 tpy; and greenhouse gas (CO₂e) 106,131.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 50, 61, 70, 71, 72, 73, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ, OOOO and OOOOa; 40 CFR 63 Subparts A, HH and ZZZZ; 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before January 14, 2024.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
